

### METROPOLITAN KING COUNTY COUNCIL NOTICE OF HEARING Proposed Ordinance 2013-0419

NOTICE IS HEREBY GIVEN that the Metropolitan King County Council will hold a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle Washington) on Monday, the 18th day of November, 2013 at 1:30 p.m. The purpose of this public hearing is to consider adoption of Proposed Ordinance 2013-0419, adopting updates to the King County Flood Hazard Management Plan (KCFHMP).

#### SUMMARY

The KCFHMP guides much-needed efforts to fix an aging system of 500 levees and revetments that protect urban and rural floodplain residents, businesses, regional economic centers, public infrastructure and roads. The KCFHMP, adopted in 2006, is instrumental in achieving King County's high rating in the Federal Emergency Management Agency's (FEMA) Community Rating System under the Nation Flood Insurance Program (NFIP). This high rating has resulted in a discount of up to 40 percent on flood insurance rates for policyholders in unincorporated King County.

Proposed Ordinance 2013-0419 amends the KCFHMP in order to comply with NFIP requirements that the KCFHMP be updated by December 31, 2013, or the discount would expire. The revisions contain no changes to policy language. The revisions update information on flood and channel migration hazards, risks to people, property, and infrastructure, and the project accomplishments since adoption of the KCFHMP in 2006.
