1 AN ORDINANCE approving the City of Tukwila

2 Comprehensive Sanitary Sewer Plan Update.

3 STATEMENT OF FACTS:

4 1. King County has adopted K.C.C. chapter 13.24, which requires
5 approval of comprehensive plans for sewer utilities that provide service in
6 unincorporated King County as a prerequisite for operating in
7 unincorporated King County, receiving approval for annexation proposals,
8 being granted right of way franchises, and being given approval for right
9 of way construction permits. K.C.C. chapters 13.24 and 28.84 prescribe
10 the requirements for approval of such plans, including consistency with
11 state and local planning requirements.

12 2. The city of Tukwila's last sewer system plan was prepared in 2005.
13 Both Washington state Department of Ecology and King County
14 regulations require sewer system plans to be updated every six years.

15 3. The city's service area is within King County and the city has adopted a
16 sanitary sewer plan update ("the plan").

17 4. King County has adopted a Comprehensive Plan that includes
18 wastewater policies in its provisions for facilities and services (applicable
19 portions of policies F-202 through F-214, and F-255 through F-264) that

20 call for consistency with other adopted plans, pursuit of reclaimed water,
21 water conservation and protection of water resources.

22 5. K.C.C. chapter 13.24 requires the utilities technical review committee
23 to review and make a recommendation to the King County executive and
24 council on the plan, the requirements under K.C.C. chapter 13.24 and
25 consistency with the King County Comprehensive Plan. The utilities
26 technical review committee has reviewed the planning data and city
27 operations and has found:

28 a. The plan uses population and employment forecasts developed by the
29 Puget Sound Regional Council and acknowledges the housing and job
30 growth targets adopted by the Growth Management Planning Council for
31 the city's service area;

32 b. A portion of the city's service area is in unincorporated King County;

33 c. The capital facility plan is adequate to meet anticipated facility and
34 service needs;

35 d. The plan is consistent with applicable Washington state water quality
36 laws; and

37 e. The plan is consistent with other pertinent county adopted plans and
38 policies.

39 6. Washington state Department of Ecology approval is pending upon
40 King County's approval of the plan.

41 7. Under the state Environmental Policy Act the city issued a
42 Determination of Nonsignificance for the plan on January 10, 2014. There
43 were no appeals.

44 8. The city's operations and facilities meet multiple existing statutory,
45 administrative and planning standards. As the city's operations, facilities
46 and planning meet the requirements of the King County Code and are
47 consistent with the King County Comprehensive Plan, the utilities
48 technical review committee has recommended approval of the plan.


49 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
