1 A RULE AND REGULATION relating to local hazardous
2 waste management fees, amending R&R 13-02, Section 3,
3 and BOH 11.04.020, and R&R 66, Section 1 (part), as
4 amended, and BOH 11.04.060; enacted pursuant to RCW
5 70.05.060 and 70.105.220, including the latest amendments
6 or revisions thereto.

7 BE IT ADOPTED BY THE KING COUNTY BOARD OF HEALTH:

8 SECTION 1. R&R 13-02, Section 3, and BOH 11.04.020 are each hereby
9 amended to read as follows:

10 **Definitions.** The definitions in this section apply throughout this chapter unless
11 the context clearly requires otherwise.

12 A. "Certified hauler" means a person engaged in the business of solid waste
13 handling having a certificate granted by the Washington state Utilities and Transportation
14 Commission for that purpose.

15 B. "Commercial solid waste collection service unit" or "service unit" means one
16 or more solid waste containers of the same size from which solid waste is collected on the
17 same regular or on-call service schedule from one site, containing only either compacted
18 or noncompacted solid waste. The occasional collection of solid waste from extra

19 containers of less than or equal to 0.48 cubic yards or ninety-six gallons during scheduled
20 service is not a separate service unit.

21 C. "Commercial ratepayer" means a solid waste collection service ratepayer that
22 is a business, nonprofit organization, public agency, school, medical organization or other
23 institution or a multifamily residential ratepayer. For the purposes of this subsection,
24 "multifamily residential ratepayer" means a solid waste collection service ratepayer for a
25 residential structure with more than one housing unit, such as a multiunit condominium,
26 apartment building or multiplex dwelling.

27 D. "Committee" means the local hazardous waste management program's
28 management coordination committee established in BOH 11.04.040.

29 ~~((C.))~~ E. "Department" means the ((Seattle/King)) Seattle-King County
30 Department of Public Health.

31 ~~((D.))~~ F. "Landfill" means a disposal facility or part of a facility at which solid
32 waste is placed in or on land and which is not a land treatment facility.

33 ~~((E.))~~ G. "Moderate-risk waste" shall have the same meaning as in RCW
34 70.105.010.

35 ~~((F.))~~ H. "Passenger licensed vehicle" means any motor vehicle licensed by the
36 state of Washington or any other state or governmental entity as a passenger vehicle.

37 ~~((G.))~~ I. "Self hauler" means a vehicle that is neither a passenger licensed vehicle
38 nor a vehicle used by a certified hauler in the certified hauler's solid waste handling
39 operations.

40 ~~((H.))~~ J. "Septage" means a semisolid consisting of settled sewage solids
41 combined with varying amounts of water and dissolved materials generated from a septic
42 tank system.

43 ~~((I.))~~ K. "Sewage" means any liquid or liquid-borne waste from the ordinary
44 living processes, liquid or liquid-borne waste that contains animal or vegetable matter in
45 suspension or solution or liquid or liquid-borne waste that contains chemical in
46 suspension or solution, and that may be lawfully discharged into a public sanitary sewer.

47 L. "Single-family residential ratepayer" means a solid waste collection service
48 ratepayer for a single-family dwelling.

49 ~~((J.))~~ M. "Solid waste" means all putrescible and nonputrescible solid and
50 semisolid wastes, including, but not limited to, garbage, rubbish, ashes, industrial wastes,
51 infectious waste, swill, demolition and construction wastes, abandoned vehicles or parts
52 thereof, discarded commodities or contaminated excavated solid or fills material. "Solid
53 waste" includes all liquid, solid and semisolid materials that are not the primary products
54 of public or private, industrial, commercial, mining and agricultural operations, except
55 that, for the purposes of this section, "solid waste" does not include source-separated
56 recyclable materials.

57 N. "Suburban city" means an incorporated city or town whose boundaries include
58 territory within King County and who has entered into a solid waste interlocal agreement
59 with King County in accordance with K.C.C. ~~((10.08.130))~~ 10.24.040.

60 ~~((L.))~~ O. "Transfer station" means a staffed, fixed, supplemental collection and
61 transportation facility used by persons and route collection vehicles to deposit collected

62 solid waste from off-site into a larger transfer vehicle for transport to a permanent
63 disposal site.

64 SECTION 2. R&R 66, Section 1 (part), as amended, and BOH 11.04.060 are
65 each hereby amended to read as follows:

66 **Fees.** The following fees are established to provide funds for contracts authorized
67 by BOH 11.04.050:

68 A. Each private and public entity (~~((which))~~) that bills for solid waste collection
69 services shall pay an amount equivalent to (~~((one dollar and eight))~~) eighty-four cents per
70 month for each single-family residential (~~((customer))~~) ratepayer in King County(~~((, and~~
71 ~~eleven dollars and twenty-four cents per month for each nonresidential customer))~~).

72 B. Each private and public entity that bills for solid waste collection services
73 shall pay an amount equivalent to the fee set forth in Table 11.04-1 per month for each
74 commercial solid waste collection service unit.

86 C. Each operator of a sewage treatment plant serving more than fifty customers
87 shall pay an amount equivalent to forty-five dollars and seventy-nine cents per million
88 gallons of sewage treated.

89 ~~((C.))~~ D. Each transfer station and landfill shall pay one dollar and eighty-one
90 cents for each passenger licensed vehicle load of solid waste, and four dollars and
91 seventy-three cents for each self hauler ton of solid waste, brought to such transfer station
92 or landfill.

93 ~~((D.))~~ E. All payments shall be based on actual performance data for the billing
94 period.

95 ~~((E.))~~ F. All fees shall be billed and remitted to the department on a quarterly
96 basis. All payments shall be due forty-five days after receipt of bill.

97 G. Each private and public entity that bills for solid waste collection services
98 shall provide an annual report of accounts and services to the local hazardous waste
99 management program in a format and on a schedule approved by the local hazardous
100 waste management program's management coordination committee.

101 SECTION 3. Effective date. This rule takes effect April 1, 2015.

102 SECTION 4. Severability. If any provision of this rule or its application to

103 any person or circumstance is held invalid, the remainder of the rule or the application of
104 the provision to other persons or circumstances is not affected.
