# SECOND AMENDMENT TO LEASE

#### Lease #1829 SECOND AMENDMENT TO LEASE

THIS SECOND AMENDMENT TO LEASE (this "Amendment") is made and entered into as of this \_\_\_\_ day of \_\_\_\_\_, 2015, by and between CURRAN PROPERTIES/FAIRWOOD SQUARE, LLC, a Delaware limited liability company ("Landlord") and KING COUNTY ("Tenant" and together with Landlord the "Parties").

### **RECITALS**

A. Curran Properties/Fairwood Square, LLC ("Landlord"), a Delaware limited partnership and King County ("Tenant") entered into a Lease dated May 1, 2005, as amended by the First Amendment to Lease dated January 24, 2008 and as amended and extended through December 31, 2014 by the agreement of the Parties on June 25, 2014 (collectively, the "Lease") for retail space located at 17620 140<sup>th</sup> Avenue, SE, C-10 in Renton, Washington that is used by the King County Sheriff's Office (the "Premises").

B. The parties desire to amend the Lease to extend the Lease Term.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Landlord and Tenant hereby agree as follows:

1. <u>Defined Terms</u>. All defined terms used in the Lease shall have the same meaning when used in this Amendment, except as noted to the contrary in this Amendment.

2. <u>Lease Term</u>. Upon approval of this Amendment by the Metropolitan King County Council and execution by Tenant, the Lease Term is hereby extended for three (3) years retroactive to January 1, 2015, and will then expire on December 31, 2017 (the "Expiration Date").

3. <u>Rent</u>. Commencing on January 1, 2015 Tenant's Fixed Minimum Rent obligation is adjusted as follows:

Time Period	Fixed Monthly Minimum Rent
January 1, 2015 – December 31, 2015	\$2,164.00 <u>\$ (833.00)</u> security presence credit \$1,331.00 per month for rent
January 1, 2016 – December 31, 2016	\$2,229.00 <u>\$ (833.00)</u> security presence credit \$1,396.00 per month for rent
January 1, 2017 – December 31, 2017	\$2,296.00 <u>\$ (833.00)</u> security presence credit \$1,463.00 per month for rent

Tenant is exempt from paying its proportionate share of Common Area Maintenance ("CAM") charges, and any operating expenses, which include property taxes, insurance and maintenance, for the Common Areas or the Premises.

4. <u>Renewal Terms</u>. The Lease Term shall be automatically extended for three (3) consecutive one (1) year periods (each a "Renewal Term") unless Tenant gives Landlord written notice of its election not to extend the Lease by no later than September 1, 2017 in the case of the First Renewal Term, by September 1, 2018 in the case of the Second Renewal Term and by September 1, 2019 in the case of the Third Renewal Term. If Tenant does not notify Landlord of its election not to extend for a Renewal Term on a timely basis, then the Lease shall be extended for that Renewal Term on the same terms and conditions as written, except that Fixed Monthly Minimum Rent shall be adjusted as follows:

(a) First Renewal Term:	\$2,365.00 (\$ 833.00) security presence credit \$1,532.00 rent per month
(b) Second Renewal Term:	\$2,436.00 <u>(\$ 833.00)</u> security presence credit \$1,603.00 rent per month
(c) Third Renewal Term:	\$2,509.00 ( <u>\$ 833.00)</u> security presence credit \$1,676.00 rent per month

5. <u>Premises</u>. Tenant is presently occupying the Premises and agrees that Landlord has no obligation to alter or improve them in any respect as a condition precedent to this Amendment.

6. <u>Brokers</u>. Landlord was represented by Suhrco, Inc. in connection with this Amendment and will pay its broker a commission pursuant to separate agreement. Tenant was not represented by a real estate broker in connection with this Amendment.

7. <u>Anti-Discrimination</u>. A new "Article XVII – Anti-Discrimination" shall be added to the Lease which shall read:

"Landlord and Tenant shall not discriminate on the basis of race, color, marital status, national origin, religious affiliation, disability, sexual orientation, gender identity or expression or age except by minimum age and retirement provisions, unless based upon a bona fide occupational qualification, in the employment or application for employment or in the administration or delivery of services or any other benefits under King County Code Ch. 12.16.125. Landlord and Tenant shall comply fully with all applicable federal, state and local laws, ordinances, executive orders and regulations that prohibit such discrimination. These laws include, but are not limited to, chapter 49.60 RCW, and Titles VI and VII of the Civil Rights Act of 1964. Any violation of this provision shall be considered a default of this Lease and shall be grounds for cancellation, termination, or

suspension, in whole or in part, of the Lease and may result in ineligibility for further agreements with King County."

8. <u>Tax Contribution</u>. Section 7.01(c) shall be deleted in its entirety and replaced with the following:

"[Intentionally deleted]".

9. <u>Errant References</u>. Any references in the Lease to "Mailboxes Etc.", "The UPS Store", "Franchisor", or "Area Franchisee" are hereby deleted in their entirety.

10. <u>Subordination and Attornment</u>. Section 13.01 shall be amended as follows: with the exception of the first paragraph of Section 13.01, the section is hereby deleted in its entirety.

11. <u>Miscellaneous</u>.

(a) <u>Continued Effect</u>. The Lease shall continue in full force and effect as written, except as specifically modified in this Amendment.

(b) <u>Acknowledgement</u>. Tenant hereby acknowledges and agrees for Landlord's benefit that, as of the date hereof, to Tenant's actual knowledge, (a) Landlord is not in default under any of the terms of the Lease as amended, and (b) there is no breach by Landlord, which with the giving of notice or the passage of time or both, would become a default by Landlord under the Lease. The Parties further acknowledge, ratify and affirm that the Lease has been in full force and effect under Section 15.06 during any period since the Lease Commencement Date that the Lease has been in hold over status and that all rent due under the Lease has been paid in full by the County.

(c) <u>Governing Law</u>. This Amendment shall be interpreted and construed in accordance with the law of the State of Washington.

(d) <u>Counterparts</u>. This Amendment may be executed in one or more counterparts which, taken together, constitute the complete document.
