1 A MOTION accepting a forty-thousand-dollar donation by
2 an anonymous donor via the Seattle Foundation in
3 compliance with K.C.C. 2.80.010.

4 WHEREAS, K.C.C. 2.80.010 requires the executive to transmit a motion when
5 receiving a donation more than two thousand dollars, and

6 WHEREAS, the anonymous donor specified that the donation be used for general
7 support of the Healthcare for the Homeless Network under the Seattle-King County
8 Department of Public Health, and

9 WHEREAS, previous donations for general support of the Health Care for the
10 Homeless Network have augmented implementation of special projects like one-time
11 startup costs for the Medical Respite Program, and unanticipated costs related to building
12 out the new Ballard Homeless Clinic, and

13 WHEREAS, for twenty-eight years, the Health Care for the Homeless Network
14 has provided health service coordination for people living homeless in King County, and

15 WHEREAS, Heath Care for the Homeless Network providers visit over sixty
16 homeless sites throughout King County, and also provides medical, dental and case
17 management services for homeless people through the department of public health's
18 centers and programs, and

19 WHEREAS, between contracted services and services provided in public health
20 centers, more than nineteen thousand homeless individuals throughout King County
21 received over one hundred thousand services in 2013;

22 NOW, THEREFORE, BE IT MOVED by the Council of King County:


23 The department of public health is authorized to accept the anonymous donation
