1	A RESOLUTION supporting the 2015 Seattle/King County
2	Clinic event and encouraging broad community participation to
3	make the event a success.
4	WHEREAS, a sizeable number of people still struggle to receive and afford the most
5	basic healthcare, even with healthcare reform. According to estimates by the Washington state
6	Office of Financial Management, approximately 138,000 people were still uninsured in King
7	County in 2014. While so many people are uninsured or underinsured, free clinics remain a
8	necessary part of the healthcare safety net and a critical resource for underserved communities,
9	and
10	WHEREAS, 3,386 patients received free medical, dental and vision care to at the
11	Seattle/King County Clinic ("Clinic") on October 23-26, 2014, at Seattle Center, and
12	WHEREAS, more than 75 organizations across Washington state, led by Seattle Center,
13	collaborated and contributed to the effort, and
14	WHEREAS, the 2014 Clinic was entirely staffed by 1,500 volunteers who provided care
15	valued at almost \$2.4 million over four days, and
16	WHEREAS, successful outreach efforts resulted in a patient population at the Clinic that
17	was racially diverse, primarily low-income and represented over thirty-one language groups, and
18	WHEREAS, Clinic patients received services not covered by basic insurance plans,
19	including diagnostic tests such as x-rays and mammograms, root canals, eyeglasses and lab tests,
20	and

21	WHEREAS, over 98 percent of the patients served reported in an exit survey that they
22	were satisfied with the quality of care and felt they were treated with respect by Clinic staff and
23	volunteers, and
24	WHEREAS, in 2015 a Clinic will be held on October 22-25 at Key Arena, led by the
25	Seattle Center and organized by over 80 local partners. The 2015 event aims to build upon the
26	previous year's success by connecting more people to long-term healthcare and increasing the
27	capacity of dental and vision care services at the event, and
28	WHEREAS, the Clinic must rent the dental and vision equipment and procure all of the
29	dental and vision supplies that had previously been provided by Remote Area Medical TM , a
30	national partner that is not able to participate this year, and
31	WHEREAS, the Clinic's scope of work for 2015 will include a task force to promote
32	meaningful community dialogue around healthcare disparities and access, and
33	WHEREAS, to provide at least the same level of service as 2014, the 2015 Clinic
34	requires 650 volunteers per day for four days;
35	NOW, THEREFORE, BE IT RESOLVED by the Board of Health of King County:
36	A. The Board of Health commends Seattle Center and the broad coalition of local
37	partners participating in the 2015 Seattle/King County Clinic for their commitment and leadership
38	in forming a community of compassionate care.
39	B. The Board of Health encourages active involvement in the event and urges medical,
40	

- dental and vision professionals to volunteer and contribute time and resources to the 2015
- 42 Seattle/King County Clinic effort.
