On page 1, strike lines 1 through 14, and insert: 2 3 "A MOTION appointing committees to write a voters 4 pamphlet statement for the November 3, 2015 special election regarding Ordinance 18088 providing for the 5 submission to the electorate of King County, at a special 6 7 election on November 3, 2015, of a proposition authorizing a property tax levy in excess of the levy 8 9 limitations contained in chapter 84.55 RCW for a 10 consecutive six-year period at a first year rate of not more 11 than 14 cents per one thousand dollars of assessed valuation, and limiting annual levy increases to three 12 13 percent in the five succeeding years, all for the purpose of 14 funding prevention and early intervention strategies to 15 improve the health and well-being of children, youth and 16 their communities."
