## AMENDMENT TO PROPOSED ORDINANCE 2015-0405, VERSION 2

2 On page 1, after line 15, insert:

## "P1 PROVIDED THAT:

Of this appropriation, \$100,000 shall not be expended or encumbered until the 4 executive transmits a report on the options available to the county to continue the practice 5 of transporting individuals from evaluation and treatment facilities to Involuntary 6 Treatment Act court ("ITA court") in the Ninth and Jefferson Building on the Harborview 7 Medical Center campus and on county expenditures related to video appearances for ITA 8 court respondents, a motion that acknowledges receipt of the report and the motion is 9 passed by the council.
