Describes key solid waste rate and transfer station capital policies in the ordinance preamble.

Sets the 2017-2018 Solid Waste Division disposal fees.

The basic fee is set at \$137.75 per ton. This fee is charged to customers disposing of municipal solid waste at King County solid waste transfer stations and drop boxes.

solid waste transfer stations and drop boxes.

• The transfer station entry fee for passenger cars is set at \$22.08 per entry.

• The regional direct fee is set at \$117 per ton. This fee is charged to commercial collection companies that houl solid waste to the Cedar Hill landfill from their own transfer stations and processing facilities, bypassing County transfer stations.

• Fees for charitable organizations, special wastes, special wastes requiring extra handling, and use of facilities without scales are also adjusted.
