9	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
10	SECTION 1. The attached 2017 King County 10 Step Hourly Squared Schedule,
11	2017 King County 10 Step Annual/FLSA-Exempt Squared Schedule, 2017 King County
12	10 Step Standardized Hourly Salary Schedule and 2017 King County Standardized 10
13	Step Annual/FLSA-Exempt Salary Schedule, are approved and adopted.
14	SECTION 2. The salary tables listed in section 1 of this ordinance, reflect a two
15	and one-quarter percent increase from the 2016 tables, thereby granting a general wage
16	increase for nonrepresened employees of the King County executive branch, King
17	County council, prosecuting attorney's office, district courts and superior courts, to be
18	effective January 1, 2017. Any nonrepresented executive branch, county council,
19	prosecuting attorney's office, district court or superior court employee, not paid from any

- 20 salary table listed in section 1 of this ordinance, shall have their wages increased by two
- 21 and one-quarter percent. These salary schedules shall not apply to elected officials,
- superior court commissioners, district court chief administrative officers or judges pro
- tem. Represented employees' general wage increases shall be governed by the
- 24 employees' respective collective bargaining agreements.
