18          passed, and





# **DAJD Report Detailing the use of Regular and Mandatory Overtime, Including Primary Causes of Overtime**

### **Introduction**

In response to Ordinance 17941, Section 48, Proviso P2, as amended by Ordinance 18239, Section 22, DAJD submits the following report of regular and mandatory overtime by month and by adult facility between January 1, 2009 and 2016 year-to-date. Also included in this report is a discussion of the primary causes of mandatory overtime, as required by P2. The Proviso calls for a second report that will be submitted by the September 1, 2016 deadline.

### **DAJD Forecast Model**

DAJD's staffing has been examined extensively over the last ten years in response to multiple recommendations calling for analysis of staffing patterns and operational practices at both the King County Correctional Facility (KCCF) and the Maleng Regional Justice Center (MRJC). Most recently, consultant CNA was hired by DAJD in response to a 2013 budget proviso to evaluate staffing and other recommendations. CNA noted that "DAJD has largely implemented many of the recommendations that are consistent with good operational practice."

Current staffing levels are largely a function of the facilities' designs, operational use, and contractual labor agreements governing work practices. For many years, DAJD has been using what CNA called, "one of the most sophisticated models for projecting staffing requirements in use by any jail system in the United States." That model is called the Operational Forecast Model (OFM). OFM projects staffing requirements based on the type and number of inmates in housing units, staffing policies, and a standard formula for computing relief factors required to provide coverage for staff during their absences. While the model is very complex, it basically identifies the posts needed to be filled in both adult facilities, the number of hours needed to fill them, and the availability of staff to fill these posts. The model allows DAJD to conduct "what-if" scenarios and measure the impact on staffing and overtime if posts were closed or added, if leave time increased or decreased, and if staffing levels were increased or decreased. The model is intended to be a predictor of regular and overtime needs.

### **Overtime Drivers**

One of the challenges for DAJD each year is determining the appropriate shift relief factor. A high shift relief factor will result in more staff than is required. A low shift relief factor will result in insufficient staffing levels. In the corrections industry, a shift relief factor commonly refers to the average number of staff that should be budgeted to fill a specific post assignment based on staff availability to fill the post, shift configuration (hours per shift), and the required number of days the post must be filled in the year.

The shift relief factor is normally determined by taking the number of hours in a year the post is required to be filled on a shift and dividing that number by the average number of hours an individual in the position classification is available to fill a post assignment throughout the year. For example, if an 8-hour post is scheduled to be filled 365 days per year and the average employee is available 1600 hours after leave time is used, the shift relief factor is 1.825 (365 days x 8 hours = 2,920 hours) divided by 1600 hours. The shift relief factor identifies the average number of FTEs required to fill an 8-hour post continuously throughout the year.

The average number of hours an individual in the position classification is available to fill a post is determined by identifying the original number of hours scheduled to work (2080 hours) and subtracting the average number of hours the individual was not available to fill a post. This is often referred to as net annual post hours and includes time for scheduled leave, unscheduled leave, training, and break time. One challenge with DAJD's current staffing model is that the shift relief factor doesn't include all the factors that might make staff unavailable to fill their post. Specifically, break-time and training are not included.

**Training:** Since training is not included in the shift relief factor, most training activities (both attendees and instructors) pull officers off their regular shifts in order to attend trainings and require other officers, either through regular or mandatory overtime, to backfill their posts. By way of example, in 2015 there were approximately 26,500 hours attributable to training activities.

**FTE/OT Mix Drivers:** Each year, DAJD plans for some level of overtime hours. Generally, DAJD targets a level of approximately 8% of total hours worked as a desired mix. However, the Adult Divisions are historically budgeted around 4%. Overtime is planned for in order to address normal variations in staffing levels without creating an excess of staff availability. When there is higher than planned demand on posts, the mix of overtime to regular FTE use increases. DAJD has had challenges in recent years maintaining a fully staffed operation due to retirements, long term medical issues, military leave, etc. It can also take six months to get new hires on-boarded and scheduled for the mandatory academy training required for corrections officers. Vacancies, combined with increased demands of the inmate population and other customers, have further driven up both regular and mandatory overtime. The following activities are the majority of drivers for overtime. However, it must be noted that any/all uses of post-driven FTEs can drive mandatory overtime, depending on variations in demand and leave usage. The following activities are the majority of drivers for overtime (2015 hours are listed to illustrate demand):

- **Psych support posts** – approximately 29,000 hours
- **Hospital guarding** – approximately 34,000 hours
- **Court detail demand** – nearly 22,500 hours
- **Increased use of scheduled** – (average of 286 hours per year per officer) **and unscheduled leave** – (average of 208 hours per year per officer)
- **Maintenance projects** – approximately 8,000 hours

**Conclusion**

While overtime is a part of DAJD's planned operations, staffing operations is challenging, without higher than planned overtime, and in the face of unpredictable changes in demand. DAJD is working with the Executive's Continuous Improvement Team to explore ways to better handle these challenges. That work and details about progress will be provided in the second report required by Proviso 2 in September.
