KING COUNTY BOARD OF HEALTH NOTICE OF RULEMAKING - BOH 16-02

A Regulation to Revise the Fee for On-site Sewage System Monitoring and Performance Inspection Before Time of Transfer of Title to Property

Pursuant to its authority under RCW 70.05.060, the King County Board of Health hereby gives notice of proposed rulemaking to adopt a revised on-site sewage system-related inspection fee.

The purpose of the proposed rulemaking is to amend the fee for the on-site sewage system monitoring and performance inspection that the seller of property served by an on-site sewage system must obtain before transferring the property's title to a buyer. The rule revises the fee from \$111.00 to \$184.80 to cover Seattle-King County Department of Public Health costs of processing the inspection report as part of the on-site sewage system oversight requirements.

A public hearing on the proposed rule at which the public may state their views orally or in writing will be held during the regular meeting of the King County Board of Health, November 17, 2016 at 1:30 p.m. in the Metropolitan King County Council Chambers, 10th floor, Courthouse, 516 Third Avenue, Seattle, WA. Written comments can also be submitted to: King County Board of Health, ATTN: Maria Wood, Public Health - Seattle & King County, 401 Fifth Avenue, Suite 1300, Seattle, WA 98104; mario.wood@kingcounty.gov. Written comments mailed or delivered to this address must be received by 5 p.m. on the day preceding the Board of Health meeting.
