1           A MOTION adopting the 2017 work plan for the law and

3           WHEREAS, the responsibilities of the law and justice committee for 2017 are  
4 detailed in Motion 14819 unless a new motion is passed, and

5           WHEREAS, Motion 14819 charges the law and justice committee with  
6 considering and making policy recommendations relating to law, safety, criminal justice  
7 and emergency management programs, excluding those related to alternatives to  
8 incarceration, and including those related to: public safety; adult detention; juvenile  
9 justice and youth services; superior and district courts; judicial administration;  
10 prosecuting attorney; public defense; implementation of a pretrial risk assessment tool;  
11 emergency medical services; emergency management, including disaster response,  
12 emergency preparedness and emergency planning and the Puget Sound emergency radio  
13 network project, and

14           WHEREAS, the committee shall also consider the implementation of appropriate  
15 labor agreements, and

16           WHEREAS, in the areas within the committee's purview, the committee shall  
17 track state and federal legislative action and develop recommendations on policy  
18 direction for the biennial budget, and

19           WHEREAS, the committee has developed a work plan for 2017 to facilitate its

20 review and development of policy options and recommendations on these and other  
21 issues, and

22 WHEREAS, the committee seeks full council support for its work plan;

23 NOW, THEREFORE, BE IT MOVED by the Council of King County:

24 The law and justice committee's 2017 work plan, Attachment A to this motion, is  
25 hereby adopted.
