Improve the landfill gas system at the Cedar Hills Regional Landfill to better control nitrogen levels in the gas delivered to Bioenergy Washington. Nitrogen is a component that decreases the value of the landfill gas and its removal is very costly once it enters the Bioenergy Plant. The supplemental will provide for the replacement of old valves and related piping in order to relieve those conditions.
