RE: Proposed Rule Requiring Limited Service Pregnancy Centers to Post Notices Stating they are Not Health Care Facilities

I am writing in opposition to the Board of Health's proposed rule which would force many limited service pregnancy centers to post conspicuous notices stating that they are not health care facilities. I am an attorney in Washington who has volunteered as a legal intern with CareNet Pregnancy Centers. As an attorney, I have seen the time and effort pregnancy resource centers put into obeying the varying laws in every jurisdiction in which they reside. Contrary to the claims made by their chief competitor, abortions clinics such as Planned Parenthood and the organizations that support them, pregnancy resource centers provide women with valuable information, choices, and resources.

The organizations supporting this proposed rule state that women have the right to access "comprehensive family planning." But as has been revealed in numerous undercover investigations, many so-called "comprehensive family planning clinics" do not provide services such as mammograms and pre-natal care. I cannot imagine that the King County Board of Health would require such facilities to post conspicuous signs in ten languages indicating that they do not provide such services. Rather than a regulation to promote women's health, this is a barely-disguised attempt to stifle competition from abortion providers.

Finally, it is important to note that similar rules in other jurisdictions have faced serious legal challenges. Currently, a similar law in California is awaiting a grant of certiorari from the United States Supreme Court. It is likely that the court will grant this petition as early as September, and will rule such laws unconstitutional. In the midst of serious health crises facing the county, including the opioid epidemic, the Board of Health has more important things to spend its time and money on than expensive legal battles. The board should focus on the issues that really affect King County residents, rather than sticking its thumb on the scale in favor of controversial organizations trying to stifle their political opponents.

Re: A RULE AND REGULATION relating to disclosure of information by limited service pregnancy centers, No. BOH 17-04

Dear Members of the Board of Health,

I am an attorney with Alliance Defending Freedom, a non-profit legal organization that regularly represent pro-life pregnancy centers providing care to women experiencing crisis and unplanned pregnancies. I am writing to you to inform you of the legal issues with proposed regulation No. BOH 17-04 regulating "limited service pregnancy centers."

The proposed regulation violates the First Amendment. Accordingly, most jurisdictions that have passed laws similar to the proposed regulation have largely been struck down as unconstitutional, including an Austin, Texas ordinance in *Austin LifeCare v. City of Austin*, No. 1:11-cv-00875-LY (W.D. Tex. June 23, 2014); a Baltimore ordinance in *Greater Baltimore Center for Pregnancy Concerns v. Mayor & City Council of Baltimore*, No. 1:10-cv-00760-MJG (D. Md. Oct. 4, 2016); a Montgomery County, Maryland ordinance in *Centro Tepeyac v. Montgomery County*, 5 F. Supp. 3d 745 (D. Md. 2014); and a New York City ordinance in *Evergreen Association v. City of New York*, 740 F.3d 233 (2d Cir. 2014).

The Supreme Court has explained that the "right to speak and the right to refrain from speaking are complementary components of the broader concept of 'individual freedom of mind." Wooley v. Maynard, 430 U.S. 705, 714 (1977). The First Amendment "presume[s] that speakers, not the government, know best both what they want to say and how to say it." Riley v. Nat'l Fed. of the Blind of N.C., Inc., 487 U.S. 781, 791 (1988). Therefore, the government "may not substitute its judgment as to how best to speak for that of speakers and listeners; free and robust debate cannot thrive if directed by the government." Id. The First Amendment protects pro-life pregnancy centers—such as those regulated by regulation No. BOH 17-04—from being compelled to engage in government-sanctioned speech. The proposed regulation would force pregnancy centers to post a disclaimer on their building and on all advertising in 10 different languages. This is incredibly burdensome and cannot be tolerated under the First Amendment. Print advertising in newspapers will be virtually impossible, as placing the disclaimer in 10 languages in addition to the



advertisement itself will be cost-prohibitive for most pregnancy centers which are non-profit and offer their valuable services for free. This is an impermissible burden under the First Amendment.

The proposed regulation is impermissibly based on the content of speech simply because it compels the content of what pregnancy centers must say. See Evergreen, 740 F.3d at 249 ("mandating the manner in which the discussion of these issues begins" constitutes a content-based regulation). Furthermore, because the regulation only applies to facilities providing pregnancyrelated services, the law is impermissibly content-based for that separate reason. "The First Amendment means that government has no power to restrict expression because of its message, its ideas, its subject matter, or its content." Police Dept. of City of Chi. v. Mosley, 408 U.S. 92, 95 (1972). "Content-based regulations are presumptively invalid." RAV v. City of St. Paul, 505 U.S. 377, 382 (1992). Even worse, the proposed regulation discriminates on the basis of viewpoint, because it regulates pro-life pregnancy centers, but exempts abortion facilities pursuant to the "health care facility" exemption. The First Amendment does not tolerate viewpoint discrimination. and viewpoint-based regulations are unconstitutional per se: "The Speech Clause has no more certain antithesis" than to "interfere with speech for no better reason than promoting an approved message or discouraging a disfavored one, however enlightened either purpose may strike the government." Hurley v. Irish-Am. Gay, Lesbian, & Bisexual Grp. of Boston, 515 U.S. 557, 579 (1995)

Importantly, the proposed regulation is much different from the California pregnancy center disclosure law upheld in NIFLA v. Harris, 839 F.3d 823 (9th Cir. 2016), petition for cert. filed, NIFLA v. Becerra (U.S. March 20, 2017) (Docket # 16-1140). Importantly, a lesser standard of scrutiny was applied by the Ninth Circuit because the California law regulated medical professionals licensed by the state. The proposed regulation, however, does not apply based on the licensure of pregnancy centers—the state of Washington does not regulate such centers in the same way that California does—but applies merely because they are providing a particular category pregnancy-related services. Therefore, the highest standard of scrutiny would be applicable, unlike the lower standard applied to the California law. Importantly, NIFLA v. Becerra is currently pending on a petition for a writ of certiorari at the United States Supreme Court, and has been listed for the Court's September 25, 2017 conference. The resolution of that case by the Court could very well mean that the California law will ultimately be declared unconstitutional.



The proposed regulation, if approved, would violate the Constitution, and should therefore not be enacted.

Dear Ms. Wood,

It has come to our attention that for the past two months Care Net Pregnancy & Family Services of Puget Sound has been named as a potential reason for a Draft Board of Health Rule and Regulation relating to Disclosure of Information. In looking over the agendas, minutes, staff notes, attendees, videos, draft language and amended draft language, we are very concerned by the insinuations and assumptions presented by Legal Voice, NARAL Pro-Choice WA, and Planned Parenthood Votes. The above listed presenters have an interest in the support of free and unrestricted access to abortion services and question the right of other organizations who support a woman's choice to continue her pregnancy.

It is even more concerning that at no time were we, or any of the other Christian agencies on Legal Voice's possible LSPC (as they call us) list, notified prior to, during or after these meetings had taken place. Legal Voice's list targets only Christian agencies that have something to do with the ability of a woman to choose life for her unborn child. These agencies include Maternity Homes, Adoption Agencies, Parenting Support Services, Material Support for mother and child, Childbirth Education Classes, Support Groups for Pregnancy Loss, referrals to life affirming medical providers and other community and state agencies that help women choose to carry to term and choose adoption or parenting. This 17-B14 will directly harm women's opportunities for support in the decision to continue her pregnancy and experience a healthy birth outcome.

Care Net of Puget Sound does not accept any federal, state or local government funding and we don't charge our patients and clients for any of our services. Rather, the value of services received in each of our program services is an average of \$425 per person. With 14,575 King and Pierce County individuals receiving compassionate accurate care in 2016, Care Net provided \$6,194,375 of medical services, maternity and parenting education, family support services/programs, healthy relationships and sex trafficking awareness education and material assistance at no cost to our patients, clients, students, the government or insurance providers.

Attached please find a sheet with quick FACT CHECKS about Care Net of Puget Sound. This is our area of service; not Legal Voice's, NARAL's or Planned Parenthood's. It seems imprudent for the Board of Health to only take the testimony of those that know nothing about our operations, programs and services, or the medical reasons and practices in place by our Medical Directors (who are experts in prenatal, OB and postpartum care). As well as to allow these individuals and organizations to help write the rules and regulations which will

impact agencies like ours by severely restricting advertising and communications and imparting the threat of financial penalties. These penalties which will be based on complaints, not from our patients and clients, but from any individual in the community like the ones who have brought this whole issue to the BOH's attention.

We believe our concerns are well founded. We also believe that there is no risk to a woman's access to abortion services or birth control in King County. We also insure that those who come to Care Net of Puget Sound are well aware of what services we provide and which we do not provide. For example, it is in our procedural flow through, set by our Medical Directors to immediately refer patients who are pregnant to OB/GYNs, Maternity Support Services and, if they lack insurance, help them obtain it. We have an Insurance "Assister" on staff and our MSS referrals help patients to access it as well.

It is our hope that you will take the time to speak with us and determine why. Thank you very much for your consideration.

The Holy Spirit worked even through a negative pregnancy test to touch Elaine's heart. She has requested continued mentoring appointments to learn more about Jesus and how to make some healthy lifestyle changes that lead to better decision-making.

We have received so many blessings and such wonderful provision from our Lord through your support in 2016. Because of these bountiful gifts, Care Net's mission continues to be fulfilled in the lives of thousands of people in need. Thank you.

"Whatever you ask in my name, this I will do, that the Father may be glorified in the Son.

In 2017, we promise to continue reaching out in new locations where our services, programs and care have not been previously offered. In each new place where we serve, we will be sharing hope, bringing help and, by the

power of God, saving lives.

Last week, a young woman came to Care Net. She was very morning sick and didn't want to be pregnant Because she didn't have any family in the area, she was worried about where to get information, encouragement and support. These factors made her unsure about carrying the baby. When her pregnancy was confirmed, we were there to offer prayer and resources and to immediately place her in Care Net classes that would help her connect with a support network of mentors and other young parents. With the availability of this help, she has chosen life for her unborn child.

With gratitude, we accomplished the following in 2016:

- 97% of women who saw their unborn child via Care Net of Puget Sound's ultrasound machines chose life.
- As God softened hearts, staff and volunteers were bold to present the Gospel. Four times as many women made profession of faith or rededicated their lives to Christ in 2016 as compared to 2015.
- Just before Thanksgiving, Care Net's first Mobile Medical Unit was delivered from Save the Storks. We are completing
 fundraising for two years of operations cost and staffing of the mobile unit with hopes of beginning to serve women
 in Seattle by April 2017.
- Care Net now has a presence in the Snoqualmie area at the Family Life Center in Fall City. Working in collaboration with CarePoint Free Health Clinic (a Christian organization), Care Net offers pregnancy testing, options education and ultrasound exams for clients twice a month in that location.

With great expection, we look forward to the following in 2017:

- Care Net is working to provide programming and support for new fathers. In 2017, Care Net will implement the
 programs planned by the Men's Task Force. Components include male client advocacy, fathers-only parenting classes
 and support groups, impact training seminars and post-abortion support for men.
- A steering committee is seeking a location for a new center in the Bellevue area to meet the needs of women in Renton, Redmond, Kirkland, Mercer Island, Bellevue, Issaquah and other Eastside communities. We will begin training those interested in serving in Bellevue beginning this year.
- We will work with churches to implement Care Net's Life Advocate Program to expand our reach to women in the church community.



- In addition to the two Medical Directors, Care Net also has the following Medical Professionals serving in our centers: 3 additional Board Certified OB/GYNs, 2 Physicians, 3 Physician's Assistants, 2 ARNPs, 3 RDMS, 16 RNs (14 of whom are trained and certified in Limited Obstetrical Ultrasounds (diagnostic).
- All Medical Services are provided by medical professionals that meet the requirements for performing the various services that we offer.
- At Care Net of Puget Sound, we work closely with the Department of Health in our areas for STD/STI screening.
- We offer screening for the three most prevalent STI/STDs in our geographic area and
 refer to the Department of Health for all the other screening and for partner treatment.
 Laboratories in our areas perform the analysis at no charge and our physicians provide
 treatment, when needed, for our patients. Partner treatment is provided by the Health
 Department.
- Care Net refers pregnant women to Maternity Case Management groups immediately following confirmation of pregnancy through diagnostic ultrasound, and gives a list of referrals for OB/GYNs in their geographic area to help with their pregnancy needs.
- Care Net has a Washington State Insurance Assister on staff to help patients apply for insurance. Insurance can be provided through maternity case management and other

agencies as well. No insurance is necessary for services rendered at Care Net of Puget Sound.

- All medical educational information has been approved by our Medical Directors for distribution to our patients. We use cited information and get most from the following sources: WA State Department of Health, the Guttmacher Institute, the CDC. Our Care Net National "Before You Decide" brochure is checked for accuracy often by Care Net National's Medical Director and is updated wherever needed.
- Care Net of Puget Sound also has a 42-member Medical Advisory Council with medical professionals from various fields of medicine. They answer questions our medical professionals may have to help a patient and can be a referral source for our patients.
- Medical Professionals serving at Care Net provide education to our patients regarding the forms of birth control. Because the overwhelming number of our patients are pregnant, the referral to the OB/GYN of her choosing is given. Once referred, the woman is then in the care of another health care provider. We close her case. After delivery, the conversation about birth control methods will be between the patient and her doctor. Care Net Pregnancy & Family Services has never intended to be a family planning clinic nor have we given any of our patients and clients the impression we are.
- Care Net of Puget Sound is earnest in our efforts to insure our patients and clients understand what services we provide and which services we don't provide. "We do not provide abortion nor do we refer for birth control" on every page of our website.. Our staff and volunteers are trained to state that we do not refer for abortion or birth control to those calling for appointments and any time that question is raised. Every client/patient who signs our intake forms must place their initials next to a statement that says that Care Net of Puget Sound does not provide or refer for abortion or birth control. We have a hanging sign stating this at our reception desk. Our commitment of Care and Competency form is also visible at our check in desk for each client to see. Please see the attached samples.
- Each woman that comes in for services is given a brief exit interview after her appointment at appointments and after education classes. In 2016, 99.7 percent of our clients/patients gave our services and staff a very favorable rating. They stated that they felt respected at all times, that they learned something new, made a positive statement on how they felt about their time with their care provider went and whether they would refer a friend or family member to Care Net of Puget Sound. 99.7% of all our patients and clients gave us very favorable responses.

As a community OB/GYN physician, former abortion performing doctor and present Medical Director of Care Net, King County, I feel that I have a broad expanse of experience, knowledge and skill in OB/GYN and perspective of my community, Federal Way, where I have lived for 24 years and raised my family. As a community physician, I see numerous patients who have had complications from their abortions including retained products of conception and infections, patients who have regretted their decision to abort their baby and request reversal of RU–486, the abortion pill or removal of laminaria that open the cervix to facilitate abortion.

Many women look back when they are having a miscarriage and feel guilty because they aborted a baby and wonder if they miscarried now because of that in the past. Some are afraid to talk about their abortions in front of the significant other. My bottom line is that I see the dark trail of what abortion clinics leave behind. More discussion of pregnancy options, not less, would help these women, presented in a non-judgmental and loving way. Introducing rules that would shut down this conversation in the name of better health is narrow minded. All of the clients at Care Net receive referrals to medical professionals or the emergency department if an emergency exists. For those who lack resources, referrals to Step by Step for medical coverage, classes for parenting or contacts for adoption are available.

I believe that clinics such as Planned Parenthood who fund their operation through abortions, feel threatened by these crisis pregnancy centers because they lose abortions from women who decide to carry their babies. Placing heavy restrictions on clinics such as Care Net, takes away vital services from these women. I ask that you do not pass the proposed rules that would effectively close crisis pregnancy centers.

We are writing to you collectively to voice our concern and objection to the proposed 17-B14 Rule and Regulation Relating to Disclosure of Information by Limited Service Pregnancy Centers for several reasons.

Firstly, the list of organizations Legal Voice gave you as potential LSPCs (as they call them) were all Christian organizations that support women with the choice of carrying to term. This list consisted of maternity homes, adoption agencies, Catholic Community Services, pregnancy centers, family support services, material support, and parenting classes. There are similar organizations that are not incorporated as Christian organizations that were not visited by an intern at Legal Voice thus showing a strong bias against medical professionals and trained employees (trained and certified in their areas of service) who are Christian.

Secondly, from our experience with Care Net Pregnancy & Family Services, and according to the Care Net of Puget Sound's medical procedural flow through, women are given immediate referrals to OB/GYNs, and maternity case management. Swift referrals and transfers to these health care providers insure continuation of care with the intent of healthy birth outcomes. This includes, finding insurance for our patients. Care Net has a trained Insurance "Assister" on staff who can help our patients sign up and receive health insurance regardless of income. Our Maternity Support Services referrals also assist in obtaining medical insurance for our patients.

Thirdly, we have agreed to be on these Councils, and Boards with Care Net Pregnancy & Family Services of Puget Sound to insure their patients get the care they need for a variety of issues (physically, mentally, emotionally, and spiritually). We have varied backgrounds and expertise in medicine and are available for consultation, referrals to providers within our area of expertise, provide care for these women ourselves at no charge, and to help other Medical Professionals know about the professional and compassionate care given to women who go to Care Net of Puget Sound for help.

Fourthly, women are notified before they are served in each center that Care Net does not provide or refer for abortions or for birth control. This is written on our brochures, on our website, hanging in each waiting room near the reception desk, and even on the intake form (with a place for the patient to initial) it states that Care Net does not refer for abortion or birth control.

Our medical professionals will explain the various methods and types of abortion procedures for our patients if they want to know. They will also, through medical consultations, discuss and educate women about the various kinds of birth control methods and how they work. Since the overwhelming number of women Care Net of Puget Sound serves are pregnant, the midwife or OB/GYN who she sees (from our referrals or from her choosing) for the duration of her pregnancy and birth will be the one to discuss options with the women. Incidentally, for the past 5 years, more than 30% of our pregnant patients were using birth control when they conceived.

Fifthly, of the 31 medical professionals actively serving in our Pregnancy & Family Service Centers, a majority

are employed by hospitals, clinics, private practices, associated medical businesses and medical centers. Most perform the same functions in the Pregnancy Centers as they do in their places of employment that ARE considered Health Care Facilities. Regardless of whether they receive financial compensation from Care Net of Puget Sound or not, those serving are considered part of the Care Net personnel. All medical services provided at Care Net of Puget Sound are performed by medical professionals with credentials and certification to perform the tasks they do.

Lastly, the organizations that have brought this concern to you (Legal Voice, Planned Parenthood Votes and NARAL Pro-Choice WA) have an interest in the support of free and unrestricted access to abortion services and appear to question the right of other organizations who support a woman's choice to continue her pregnancy. Should 17-B14 be passed, the burden placed on Pregnancy Centers who meet this spurious criterion will be great. Without Pregnancy Medical and Family Services Centers, fewer women will have support to choose life for their unborn and receive help with that decision. This rule and regulation harms the very women it is purported to protect.

On behalf of the mentioned medical professionals, I sign my name as the Coordinator of the Medical Advisory Council.

Thank you for relaying my comment to the King County Board of Health.

I appreciate the King County Board of Health for all they do to keep our county safe and healthy. I further appreciate the Board of Health's commitment to improving healthcare for pregnant women. However, I am not convinced that this rule will improve healthcare for pregnant women. This rule requires pregnancy centers to post a sign on their property that says "This is not a healthcare facility" in ten different languages. I do not know how branding pregnancy centers with this sign improves healthcare for pregnant women. To many, it appears that this rule is designed to punish pregnancy centers for opposing abortion and not offering comprehensive contraception services.

If this rule is enacted, I am concerned many healthcare professionals who work in these centers will become angry with the Board of Health. This would result in growing resentment directed at the Board of Health among a significant portion of King County residents and workers. The Board of Health is not a political body but a committee that acts to protect King County residents using only nonpartisan and uncontroversial solutions backed by the community and scientific evidence. I am concerned that if this rule is enacted, the Board of Health will be seen as a political body and treated as such in the future.

I encourage the Board of Health to reach out to these pregnancy centers to see if a solution can be found that benefits everyone involved in King County before enacting this rule. I believe that the Board of Health will see impressive results in the service of pregnant women in our county if we work together on this issue.

Care Net provides a valuable service to the community and should be considered a vital means by which community health care transformation is occurring in this country. Without the burden of taxpayer money, Care Net is able to offer pregnancy testing, ultrasound and Sexually Transmitted Infection testing at no cost.

By working working with community partners, to include Step by Step Maternity Case Management, as well as the Tacoma Pierce County Health Department, continued care is provided and assured. Care Net also provides referrals to the Tacoma Pierce County Health Department's Black Infant Health program. This program focuses on infant mortality in the African American community in Pierce County.

The mortality rates for black infants is disproportionately high. African American women tend to have more pregnancy complications, leading to low birth weight. This can then have a further affect on infant mortality due to Sudden Infant Death Syndrome. This program demonstrates that through community partnerships with Care Net, area churches and their lay health ministers, as well as other community organizations, we can improve the rates of low birth weight and infant mortality in Pierce County.

By identifying at-risk women and referring them into the Black Infant Health program, we are providing potentially life-saving resources to underserved women. It's important that we not limit access to care to those most vulnerable and in need of professional and compassionate care.

As an African American woman, my hope is that freedom of choice when it comes to reproductive health care can extend to allowing unhindered access to a free clinic, providing personable, whole person care, rather than pay to go where either I or my child are viewed as a burden to the already stretched medical system.

The arguments presented in the brief made available to the public for download (Staff Report prepared by Scarlett Aldebot-Green) were highly prejudicial against these organizations. Nearly every footnoted "fact" listed in the paper was from a Pro-Abortion organization such as Planned Parenthood, NARAL and Legal Voice. I would like to point out that Planned Parenthood does not provide comprehensive pre-natal care for their clients either. They will provide contraception, STD testing (also conducted by many of the faith-based organizations), pregnancy tests and abortions. Both Planned Parenthood and the faith-based organizations have to refer their clients to other facilities for things such as mammograms and other standard reproductive health screening exams.

The other "argument" presented in the Staff Report was a detailed description of a hearing held in Olympia in 2010 for SB 6452 and companion bill HB 2837. The testimony presented in that hearing was apparently insufficient for either bill to pass, and no other attempt has been made in the last 7 years on the State level to infringe on the rights of these faith-based organizations.

I would like to ask: You propose forcing faith-based organizations to place signage letting their clients know that abortion is an option, but will you also force organizations that provide abortions to place signage in 10 languages at a 48-point font size (printed at their expense) that will let their clients know that choosing not to end the human life in their womb is also an option, and that there are organizations out there that will help them through the process of carrying that life to term? Will they also be fined if they do not put these signs up?

Most Crisis Pregnancy Centers are not there as medical facilities, and have never pretended to be. They are there to provide a resource for women facing an unexpected pregnancy with options other than ending the life they carry. They are there to provide things such as medical referrals to standard doctors or specialists. To provide classes in parenting should the woman be thinking of keeping the child. To provide basic supplies after those mothers have had the child. To provide referrals should the woman decide that adoption is the right choice for her and the life she carries.

Yes, many do have fully trained and licensed medical staff who volunteer their time to provide exams, and conduct pregnancy tests, but most are volunteers there to support the woman as she struggles with the decision to proceed with the pregnancy or not.

They are a very necessary alternative for women who have decided to continue the pregnancy, because God knows, Planned Parenthood is not advocating that they continue the pregnancy.

Please know that I, and many others who believe as I do, plan to attend the meeting on the 20 th to ensure that
you are fully aware of our thoughts on this matter. I hope you will carefully consider this matter prior to you
vote.

Hello Maria,

I am writing to you with my personal testimony in regards to the hearing on July 20th at 1:30 for the regulations on pregnancy crisis clinics such as CareNet.

About a year and a half ago, I discovered that I was pregnant with my second child and that the insurance our family had did not cover prenatal or pregnancy related visits whatsoever. This meant that if I wanted prenatal care, we needed to pay for it completely out of pocket which for us, meant we could only afford the very bare minimum (monthly visits but no ultrasounds).

I found out about CareNet through someone heavily involved in the ProLife community and while I was not considering an abortion, this person told me that CareNet helps provide services to moms without any charge and that I could probably get an 8-week ultrasound for free. I made an appointment and even though I was fairly skeptical, the staff was incredibly professional and very friendly.

CareNet was able to give me an 8-week ultrasound (at zero cost to me) and they were also able to provide the crucial information that I was actually 2-weeks further along than I had thought which I could not have found without that early ultrasound (apparently after 20-weeks it's harder to date a fetus).

CareNet and other clinics like them are filling a need in our community to help women in a way that no other place is. As a young woman in Seattle, I am saddened and appalled that you want to put regulations on these places that would make it more costly for them to operate and make them unappealing and quite frankly, scary, to a woman looking for help that is not in the abortion realm. The regulations seem so stringent that it is possible some of these clinics would possibly close which would be a huge disservice to women and especially poor women in our community. This SHOULD be something that you are advertising on our county website and not pushing away. As a voter and a person who loves Seattle and being a Seattleite, I am so sad you are not willing to help woman more. Who cares if its run by the Pro-Life community? And actually, while I was there, they were quite specific to mentioned all the options I had available to me-keeping it, adoption, and abortion.

As a voter and someone helped by these services, I am asking you, please do not put regulations on them that would be costly or interfere with them helping women. I am asking you, please do not put any regulations on them.

Councilman Rod Dembowski, Chair Ms Maria Wood, Administrator Councilmembers King County Board of Health

I write to comment on R&R BOH 17-04. I urge you to REJECT it based on several concerns, generally that it conflicts with Democratic positions:

- 1. It looks like crony capitalism, the board being used to promote unfair business practices;
- 2. It infringes on freedom of speech and has been struck down in court;
- 3. It is anti-choice;
- 4. It is culturally insensitive/imperialistic.
- 5. It is applicable in other situations where you would never apply it.
- 1: Crony capitalism: the Board is acting largely at the behest of an entity which stands to profit by limiting the competition. This looks like commercial partiality and reflects poorly on the Board's stewardship of public trust. You are supposed to be an impartial regulatory agency ensuring a fair market and level playing field. But one side is asking you to enforce against the other side, and you seem more than willing to take sides instead of resisting this unethical request. This violates democratic ideals of equity and fairness in business, and undermines the very role of government as necessary to regulating the free market.
- 2: Infringes on free speech, struck down in court: a very similar attempt to enforce government-mandated speech upon a Maryland LSPC was nullified in a US District Court ruling last fall, and another in Austin Texas was in 2014. Freedom of expression and freedom from government compulsion is a hallmark of Democratic

reproductive health policy, and 17-04 contradicts that. It is unwise and undemocratic to try to pass a regulation similar to others that have been struck down.

- 3: Anti-choice: you have long championed abortion using the philosophical basis of choice. 17-04 and the underlying research clearly seeks to limit/deny choice. LSPCs are not nearly as publicized as abortion centers, and women find them only by their own effort of searching, not by stumbling over them, so there is little chance that women are deceived by them; women have CHOSEN LSPCs, the LSPCs are up-front anyway (the staff report tries to have it both ways, saying LSPCs don't inform of abortion and they counsel against abortion), and the women's informed choice should be respected, not disrespected, especially by lawmakers who prominently espouse choice. Abortion clinics don't promote adoption etc, nor do they offer comprehensive health care; they should be equally subject to this notice requirement.
- 4: Culturally insensitive/imperialistic: you know King County is culturally diverse. Many non-white cultures prefer to preserve life rather than abort. To impose these white pro-abortion values on these immigrant women of color is culturally imperialistic. LSPCs do not in any way impede women from choosing abortion, there is no problem of denial of abortion that needs to be solved.
- 5: Applicable where you won't: other facilities under KCBOH/PH-SKC purview should, by 17-04's logic, also need to offer notice of limited services, but don't, proving that the proposed notice regulations are excessive and unnecessary and that the motives behind 17-04 are not health but suppression of dissent:
 - a) Vegan restaurants which don't offer meat: you don't require them to post in 10 languages in 48-point font that they don't serve meat and don't offer sufficient dietary iron on their menus;
 - b) Alternative-medicine practitioners and vendors: naturopaths, acupuncturists, supplement stores and nutritionists: you wouldn't require them to post in 48-point font in 10 languages that they're not a health care facility even though they don't have a licensed MD onsite and don't offer comprehensive health care options;
 - c) Brownfields and MTCA/NPL/Superfund cleanup sites like the Lower Duwamish: you don't require posting in 10 languages in 48-point font that they are hazardous to health, even though the harm from these sites is far more than the harm from a LSPC.
 - d) I've been to PH-SKC's Northshore clinic, and there's no notice in 48-point font in 10 languages there.

For all these reasons of philosophical contradiction and potential liability to the Board, I urge you to REJECT 17-04.

Much of my thinking and choices were still being driven from the hidden trauma of going through this experience alone and in terrible fear of being pregnant with no one to help or support me at that vulnerable young age (15 y/o).

Care Net provides a vital and important service to women in crisis, offering them hope, assistance, compassion and understanding during the decision-making process we each have had to face in a very difficult situation. The team of people behind Care Net who make this work their daily ministry, reaching out to those most vulnerable women, dramatically changes the trajectories of lives every day. Their tireless pursuit in finding and helping as many women as they can reach, makes the critical difference in future quality of life for everyone they touch. Care Net makes it possible for these women to move through the pain and negative impacts of their choices, often times unaware, that many experience after abortion. When I had two abortions in my early 20's, I had no idea how those decisions would impact the rest of my life. It was in the late 70's, a time of sexual freedom with no apparent consequences. As it turns out, all of our choices have consequences.

I struggled with depression for years, a deep sense of shame, insomnia and many other symptoms of post-traumatic stress disorder that I never connected to the abortions I had decades earlier. It was, and still is, considered a choice, with no lasting emotional or psychological impact. This is a lie. I was going through a very painful divorce in 2006 and found out about Care Net that summer. I went through the 10-week Healing Tide class for postabortive women and it was a turning point in my life. Finally, I was able to share the pain of carrying this shame and guilt, the knowledge that I had taken the lives of my own children, with women who understood and could identify with what I was feeling. They listened, cried with me, encouraged and helped me walk through the grieving process. I was finally able to put my children to rest and find the peace that had eluded me for decades. I will be forever grateful to those wonderful women at Care Net and their investment in my life.

I have since led many other women through the same process, and have seen the same changes in them that I experienced – from depression to hope, from the burden of shame and guilt to the freedom of forgiveness.

My daughter got pregnant in 2010 and was seriously considering an abortion. I'm so thankful I was able to convince her and my grandson's father to go to Care Net for an ultrasound. When they saw the reality of the baby she was carrying, they knew there was only one decision they could make. I often think of that when I look at my precious grandson, who is now 6, and the joy of my life.

Care Net has made all the difference in my life. I'm thankful for the professional, dedicated volunteers who are making a difference in the lives of others every day, especially those who are unable to speak for themselves, like my grandson.

Freedom to live: How Care Net changed my life after sharing my secret I had held onto for 37 years.

I didn't know much about Care Net but had heard throughout a 10-year period that they had offered a class on post abortion recovery. I never had the courage to call.

I had my first abortion when I was 13 years old. My mother insisted on me having it. What choices did I have? I was only 13. I don't remember having my own thoughts about it. I just knew I had to listen to my mom.

My life changed at that moment. The sorrow came in like a flood. I pushed it down. I began to drink heavily and began experimenting with drugs. I slept with countless men looking for love just so I could feel. I struggled with deep depression, I was numbed with pain. I drank for ten years.

At the age of 23 I knew my life needed to change so I got sober. Three months later I found myself pregnant again. I remember the fear that welled up inside of me again. The only answer I knew was to have another abortion. The sorrow and remorse I felt afterwards was overwhelming. It's a miracle I didn't start drinking again.

I knew that on my own I had made a mess of my life. I began my search.

I went to church and found some healing and direction in my life. I met my husband 11 months later, got married and had two daughters.

I was still suffering from deep depression and unable to really bond with my girls. I remember always having an overwhelming fear to protect them. Control took over my life.

Through the next 18 years my depression got worse and affected all aspects of my life.

My post abortion Experience

When I was a 17-year-old teenager, in 1980, I became pregnant. This of course was not planned and was a very scary thing to have happened to me. Not knowing what to do, I found myself at a Planned Parenthood center wanting someone to help me with a decision. They were very quick to give me referrals for abortion. In the end, I followed through and had the abortion. It was the most awful and tortuous experience of my life. For years after this experience, I suffered guilt, sadness, anger, pain, self-hate, insecurities and I was very unforgiving to anyone who had helped me in making that decision.

It wasn't until I was in my late 40's that I found relief from that pain. That pain was finally gone after going through a Care Net post abortive recovery program. For the first time in my life I understood that my decision was forgiven. I was finally able to forgive myself and eventually move forward into helping other women, like me, to know the love that was waiting for them with open arms. Through Care Net, I found a group of women who had gone through experiences that were similar to mine and without judgement. I found a bond with these women and I received so much healing. If it were not for Care Net, I would still be hanging onto the pain of that decision that I made so long ago. I am so grateful for the people who volunteer for this amazing center. I am a different (better) person because of it.

Being 17 and pregnant again. A year ago, Olivia went to a health clinic to get a pregnancy test and counseling on how to move forward with an unexpected pregnancy. She left with the abortion pill, called her auntie and asked that she meet her at the family cabin.

When Aunt Kerry arrived, Olivia was in pain and spitting up blood. Kerry didn't attend the original appointment with Olivia, and neither one of them understood the side effects of RU-486. Not only was it traumatic for Olivia to go through, but hard for Aunt Kerry to witness her niece in so much pain.

Fast forward to a year later, Olivia found herself pregnant again and confided in her auntie. She knew she didn't want to go through what she did the previous year. Through a friend, Kerry reached out to one of Care Net's office mangers. Gina was upfront in the beginning of her conversation with Kerry, letting her know we don't refer or perform abortions, but her niece would get medically accurate information, a free ultrasound to verify a viable pregnancy along with non-judgmental encouragement and support.

Olivia agreed to have her auntie bring her into one of our centers, and first met with her client advocate, Jennifer. They discussed abortion, adoption and parenting, all three being her options. Olivia was open about her situation, being a pregnant teen, her home life, her relationship with her boyfriend, her goals, and who would be her support system during this time in her life. She also shared about her previous chemical abortion and how she wished the "other" clinic would have discussed the physical side effects and emotional distress that she experienced.

That same day at Care Net, Olivia met with Lola, our head nurse and had a 1st trimester ultrasound that confirmed a viable pregnancy. They also discussed fetal development. She was given the opportunity to ask questions about abortion, adoption and parenting. At the end of her appointment, Olivia stated that she wanted to continue her pregnancy. Nurse Lola told her about how we can support her if she chooses to carry with our parenting mentor program. A program which offers informative, practical topics along with maternity and baby supplies.

On her way out, Olivia stated that she felt we were very understanding, nice and would refer anyone to our center.

A few weeks later, we received this letter from Aunt Kerry;

"I just wanted to thank you so much for all your help and kind words. What you're doing truly does make a difference and we appreciate you. Because of you and your co-workers, my niece decided not to terminate her pregnancy. We are forever grateful." Sincerely "Kerry"

Dear Ms. Triller,

I wanted to share my story with you so that you could then share it at the hearing. Please feel free to use my email.

I was 19 and a premed student at Princeton University when I had an unplanned pregnancy. When I went to student health, I was told that I was pregnant after I had a positive pregnancy test. I can remember my conversation with the counselor as though it were yesterday. She said, "You're going to have an abortion, aren't you?" No support was offered nor were there discussions to alternatives to abortion.

I told her that my boyfriend and I would want to keep the baby, get married and finish school. Her comments were that I would never finish school and that I would not be able to go to medical school with a child.

The university would not pay for the delivery but they would pay for an abortion.

My boyfriend and I did marry and we had our healthy beautiful son Jamin the next September. We had our second son during my senior year so I graduated for Princeton with 2 sons!

I went on to graduate from Temple University School of Medicine and chose Family Practice as my specialty. I was the Chief Resident of our program. I've been practicing now for almost 25 years.

As a physician, I know that good health is not just physical but also emotional and social.

I didn't have any support from the community in college and I wished there had been a center like Care Net of Puget Sound to have been there for me to provide family support services and referrals, parenting classes, material support and referrals to organizations to help with the multitude of needs I faced.

The services you provide would have given us additional support and made the road easier. Thankfully today, women have the tremendous benefit of centers like yours to help set up a network of care that help women thrive.

If your center were not around, women would be facing the kinds of struggles I had so many years ago. Thankfully they have help today and hope for tomorrow because of the work you do!

Pro-choice means supporting a woman's right to choose. My husband and I chose life for our son and we have been experiencing a full life since making that choice.

This comment is submitted in relation to Proposed Rule & Regulation No. BOH17-04.1.

1. The Board's fact-finding process used to develop rule BOH17-04.1 grossly violates due process and proper administrative procedures.

Administrative agencies like the Board of Health have a legal and professional obligation to develop regulations through a fair, impartial, and independent process. Moreover, any regulations adopted must be based on adequate findings of fact. However, the staff report submitted with proposed rule BOH17-04.1 makes clear that no independent or impartial fact-finding process was used to develop this rule. Instead, the Board delegated its own fact-finding responsibility to private political lobbying groups, relying wholly on one-sided reports issued by NARAL, Planned Parenthood Vote!, and Legal Voice. This was egregiously improper for the following reasons:

- a. NARAL, Planned Parenthood Votes!, and Legal Voice are not neutral or impartial investigative organizations. They are lobbying groups that advocate abortion rights and harbor a clear animus towards groups that favor restrictions on abortion. Despite this fact, they were relied upon by the Board and its staff to investigate pregnancy centers that exist in large part to oppose and provide alternatives to abortion. It strains credibility to believe that these organizations could act as neutral and impartial fact-gatherers in such a situation. It would be akin to the Board devising a rule to restrict Planned Parenthood's activities based solely on an investigation by the National Right to Life Committee.
- b. Most of the allegations of misinformation and deceptive practices made by Legal Voice and allied groups are vague, irrelevant, or not properly documented or sourced. For example, the 2011 "study" cited in the staff report was based wholly on anonymous sources, making the allegations impossible to verify. Moreover, a number of the pregnancy centers investigated in the 2011 study were outside King County, and so they are not even under the jurisdiction of the King County Board of Health. The 2017 study by Legal Voice also relies on anonymous sources, and it provides paraphrases of supposed misstatements without documenting the actual wording of the supposed misstatements. For example, the report asserts that at one clinic a person "was given medically inaccurate information about abortion, including that it causes infertility, sterility, breast cancer, and pelvic inflammatory disease." But without documentation of the actual wording (for example, providing a copy of a pamphlet that contained this information), it is impossible to know whether this assertion (by another anonymous source) is a fair description of what she was actually told. These kinds of vague and unsubstantiated allegations do not provide a reasonable basis on which to base the proposed rule—especially when they were gathered by partisan lobbying groups rather than neutral investigators.

c. There is no evidence from the staff report that any of the pregnancy centers targeted by the proposed rule were afforded the right to respond to the allegations made against them, let alone to question their anonymous accusers. Indeed, the staff report describes a briefing for the Board of Health on May 18, 2017 that only included two county officials and a representative of Legal Voice, one of the lobbying groups opposed to the pregnancy centers that are the focus of the new rule. Notably absent was *any* representative of the groups under attack. This makes a mockery of any legitimate fact-finding process by an administrative agency.

Frankly, it is incredible that the Board would even consider the current proposed rule given the sloppy, partisan, and one-sided nature of the supposed fact-finding process. If the Board wants to consider a rule like this one, it needs to start the process over again with a genuine fact-finding process, one that is not delegated to political lobbying groups and that gathers and presents facts and statements from both sides.

2. As currently written, proposed rule BOH17-04.1 violates the free speech rights of the pregnancy centers to be regulated.

As previously stated, the Board's fact-finding process was neither impartial nor independent; it was handed over to political lobbying groups with a clear ideological animus towards the groups they were investigating. By relying completely on those lobbying groups' one-sided reports, the Board raises serious questions about the real purpose of the proposed rule. It should be noted that many of the statements highlighted as objectionable in Legal Voice's 2017 study relate to the pregnancy centers' religious views, their views on abortion, and even their opinions about Planned Parenthood. For example, the study highlights as objectionable certain statements by a doctor that "a baby is a blessing" and "pregnancy is a gift," a comment by a staff member that "abortion could take a huge emotional and spiritual toll," and the distribution of a pamphlet that criticizes Planned Parenthood for performing abortions. By any standard, many of these statements are clearly constitutionally protected speech. By adopting the Legal Voice report as part of the factual basis for its rule, the Board and its staff are providing evidence that their real intent is not to achieve a valid public health purpose but to chill and punish constitutionally protected speech through the coercive powers of the state.

The details of the proposed rule further substantiate that the real intent is to punish protected speech:

- The purported findings of fact included in the rule make clear that the Board opposes the targeted centers primarily because they do not promote abortion or provide contraceptives. In other words, the centers are being targeted because of their constitutionally protected point of view.
- The actual statement mandated by the Board is only loosely related to the actual
 allegations being made about the centers. Whether or not the targeted pregnancy
 centers have made misstatements about abortion or contraceptives, the
 information in the record does not demonstrate that any of the centers have
 misrepresented themselves as full-service health facilities or even that they have


claimed to provide abortions or contraceptives. Indeed, the 2017 study by Legal Voice concedes that one of the three centers it criticizes made clear to clients that it doesn't provide abortions or contraceptives. In addition, there is no evidence in the record to demonstrate that any significant proportion of women have been misled into thinking that these centers are full-service health facilities. So there is no rational basis for the wording proposed by the Board. Again, the real goal appears to be restricting constitutionally protected expression by those who do not favor abortion.

- The proposed rule would apply to pregnancy centers regardless of whether they had actually engaged in any inaccurate speech or deceptive practices. In other words, a pregnancy center is essentially judged guilty by the Board without any investigation or hearing. This again suggests that the real problem is not misstatements by these centers but that they oppose abortion or contraceptives, a constitutionally protected message that the Board disagrees with.
- The proposed rule mandates that the Board's disclaimer be included not only in a posting at the physical location of the centers, but in every digital, online, and print advertisement or flyer. This mandate would effectively censor the centers' free speech rights by making many forms of advertising essentially illegal for the targeted centers. For example, the rule effectively bans the centers' from being able to purchase small classified ads, short business listings in phone directories, and small display ads, because it would be technically impossible to fulfill the rule's requirements with these ads. The rule demands that "any" ad—no matter how small—has to contain the Board's statement in 10 different languages. Moreover, the Board's mandated statement must be in a font size larger than any surrounding text. A simple paid listing in a phone directory could not physically accommodate this demand. Even ads that are larger would become effectively useless under this required. Since the Board requires that its own statement appear in a font size larger than surrounding text (as well as be highlighted in other ways), the Board's message would effectively dwarf any message the centers want to convey in their ads. For all practical purposes, the Board is trying to compel the pregnancy centers to use ads they pay for to communicate the Board's message instead of the pregnancy centers' message. The Board's allencompassing requirement places such a significant burden on the centers' free expression that it is essentially a gag order on the centers' constitutionally protected speech rights.
- The proposed rule would prohibit pregnancy centers from placing any additional information on the Board-mandated statement, again clearly violating the free speech rights of the centers. Under the Board's proposed rule, the centers could not even add an explanatory note that the statement "This facility is not a health care facility" was posted as required by the Board of Health. Nor could the centers add wording that the Board-imposed statement does not reflect the centers' viewpoint. Hence, not only is the Board attempting to coerce the centers into communicating the Board's message at the centers' expense, it is essentially compelling the centers to mislead their clients by making the centers falsely represent the Board's disclaimer as their own statement.

• Any center that violates the speech restrictions imposed by the Board would be subjected to ruinous fines of up to \$36,000 per year, which would likely put any center out of business that does not comply.

3. Adoption of proposed rule BOH17-04.1 will erode public support for the Board of Health's valid public health activities.

In order to achieve its important objective of protecting public health, the Board of Health needs the continued trust and support of the general public. But if the Board adopts the present regulation, it will undermine its credibility with the significant minority of the population in King County who support efforts to provide alternatives to abortion. Public health is too important to become a political tool in the culture wars. The Board of Health should not misuse its legitimate powers in order to try to shut down legitimate differences of opinion on abortion. If it does so, it should not be surprised if many members of the public begin to view statements and policies adopted by the Board of Health as simply expressions of partisan ideology rather than public health. The Board may eventually find that large segments of the population no longer take seriously its pronouncements because they cannot trust the Board to act in a professional and impartial manner. This would be a serious blow to public health policy in King County.

Dear Board Members,

I am the Medical Director of Women's Accessible Medical Services, P.S. (WAMS). I graduated from Washington State University and University of Washington School of Medicine and have been a physician for 39 years. I am also Board Certified in Obstetrics and Gynecology and Maternal-Fetal Medicine, and am a Fellow of the American Congress of Obstetricians and Gynecologists.

WAMS is a 501(c)(3) Professional Services Corporation governed by a Board comprised of licensed health care professionals, including MDs and RNs. WAMS operates 3W Medical for Women (3W Medical), a new medical clinic located in the University District. Its medical services are provided under my supervision and participation in patient care as medical director. We are incorporating other volunteer physicians as well. We recently learned that 3W Medical has mistakenly been identified as a "limited service pregnancy center" in documents accompanying the Meeting Agenda scheduled for July 20, 2017.

To be clear, 3W Medical contests allegations contained in the white paper accompanying the Meeting Agenda Packet.

3W Medical does not fit the definition of a limited service pregnancy center as provided under the proposed rule and does fit the definition of a health care facility. Specifically, 3W Medical is a "clinic . . . where a licensed health care provider conducts functions governed by chapter 70.02 RCW." Further, its "primary purpose" is neither to provide "pregnancy options counseling" nor to provide pregnancy tests. Indeed, since seeing our first patients in May 2017,

WEBSITE 3WMEDICAL ORG two thirds of our services have been unrelated to pregnancy, including general gynecology exams, as well as STI and STD testing and treatment for both male and female patients.

Nevertheless, the broad scope of the proposed rule's definition has resulted in parties mislabeling 3W Medical as a limited service pregnancy center and inaccurately describing it as an "organization with the express purpose of discouraging pregnant people from having abortions or using contraceptives, and encouraging people to carry their pregnancies to term." Consequently, as written, the proposed rule appears to have the potential of sweeping within its scope healthcare services provided by licensed medical professionals governed by Chapter 70.02 of the Washington Revised Code, practicing at facilities such as 3W Medical.

The overbroad language of the proposed regulation lists as criteria services that are found in every medical office that provides obstetrical care. Although this should not be the intent of the regulation, it inadvertently could imply that any physician practicing obstetrics might be covered by the definition. This is a concern for both profit and non-profit medical providers.

In conclusion, it could not have been the intent to rely upon overbroad language that implicates the practice of medicine by physicians.

Dear Drs. Danielson, Daniell, and Delecki,

I am writing to oppose the proposed regulation R&R No. BOH17-04 because it does not meet standards of evidence for medical decision making and it would not be a reasonable use of taxpayer money.

As you are aware, staff at King County with support by interested parties such as Legal Voice have presented oral and written testimony which is on record on the King County website. They have sent undercover "testers" into centers to collect evidence trying to show these are not healthcare facilities. These unverified, biased stories have then been presented to the Board of Health. However, no independent evidence is being presented.

The process to collect the evidence bears no resemblance to scientific inquiry. Using as a guideline the standards established by the <u>U.S. Preventive Services Task Force</u>, the so-called "evidence" presented to support the King County Board of Health proposed regulation related to disclosure of information by limited service pregnancy centers is unquestionably insufficient.

If the health professional members of the Board of Health vote "yes," you will be breaching commitments to an evidence-based approach to public health.

In addition, King County staff testified that the annual cost in salaries to enforce this new regulation would be \$40,000. This too is in the public record. Wouldn't this money be better spent on our homeless or opioid epidemics?

To Whom It May Concern:

I am writing as a healthcare provider to voice my concerns about the dangerous impact of Crisis Pregnancy Centers on our communities. I am a certified nurse midwife who offers the full of range of services within my scope of practice, including both abortion care and pregnancy care. I believe firmly in respecting the dignity and autonomy of all pregnant people, regardless of whether or not they intend to continue their pregnancies.

Crisis Pregnancy Centers present themselves as healthcare centers attentive to the needs of people in crisis – many of whom are young women of color. In fact, these Centers are staffed by people who are not medical providers, providing false "medical" information and preying on the vulnerabilities of those who come to them in a time of need. As a healthcare provider, I have seen the negative impact these centers have had on my patients many times. Two specific incidents come to mind that illustrate the unethical practices of these centers.

Once I was providing follow up care to a young woman who had recovered well from a two-day abortion procedure in her second trimester. At the end of our visit she became tearful and expressed anger toward herself that she had waited until so far in her pregnancy to seek care. As we discussed her feelings, she told me that she had initially presented for care at a Crisis Pregnancy Center at around 6-7 weeks of pregnancy, thinking she was going to a healthcare facility that could provide her with safe medical care. After receiving an ultrasound, a lot of false medical information about the dangers of safe legal abortion, and a lecture on her responsibilities as a mother she left the pregnancy center feeling alone, scared, and guilty. Although she was certain she couldn't continue her pregnancy, she was terrified she would have the same experience elsewhere. By the time she worked up the courage to come to my clinic, she required a longer, more painful, more invasive procedure that – while still very safe – carries a greater risk of complications that the simple aspiration procedure she could have gotten at 6 weeks of pregnancy.

On another occasion, a medical interpreter alerted the front desk staff at my clinic that someone had snuck into our lobby and was harassing patients. The person in question was a middle-aged woman posing as the "victim" of an abortion that had left her devastated by depression and pain. She was giving our patients small notecards warning that abortion would lead to depression and suicide. The cards had a phone number written on them and said, "we can help!" The woman quickly left when she realized the interpreter had caught on to her. Afterward I called the phone number on the card and it was a Crisis Pregnancy Center. This was not only an example of spreading false medical information in order to coerce pregnant people; it was also a violation of federal law.

The practices are unethical, harmful, and illegal. Crisis Pregnancy Centers pose a significant danger to some of the most vulnerable members of our community, and cannot be allowed to continue operating in this way. I encourage you to take action to protect our communities and ensure access to safe, respectful, and legitimate medical care for all pregnant people.
