Key Strategic Issues Underway

- **Develop and apply Actuarial Needs Assessment for program planning, transition and resources allocation, validate tool for KC**
- **Survey/review all existing DAJD programs and practices, make needed changes to align with EBP**
- **Develop/implement comprehensive release planning and reentry services continuum**
- **Implement trauma informed EB treatment in DAJD**

Mini Tasks Completed

- Established working definition for King County Recidivism
- Analyzed and defined base line recidivism rate
- Implemented Work Source Program at MRJC
- Reviewed DAJD Programs
- Developed foundation for RNR Tool and practices
- Revised PR Investigator Report for Courts to launch in January
- RNR tool development in final phase
- Hair Care for Jail Population

Recidivism – as defined in King County

- Any offense committed by a person within 36 months in the community (after release from confinement) or the completion of a therapeutic court program, that results in a Washington State Court Legal Action.
- **A court legal action** includes conviction, deferred sentence, deferred prosecution, deferred disposition or a diversion agreement as defined by Washington State statute for misdemeanors, gross misdemeanors and felonies
- **Reincarceration differs from recidivism**; it involves a return to custody for reasons other than a new sentence and may include technical violations

The greater number of the needs addressed simultaneously can provide the greatest behavior change. Failure often results in ..




