1	A MOTION concerning the regional policy committee
2	review of the mental illness and drug dependency
3	evaluation and implementation plans.
4	WHEREAS, the King County Charter establishes regional committees to develop,
5	recommend and review regional policies and plans for consideration by the metropolitan
6	King County council, one of which is the regional policy committee, and
7	WHEREAS, the charter and K.C.C. 1.24.065 establish a one- hundred- twenty-
8	day timeframe for the legislative review process for countywide plans and policies within
9	the subject matter adopted by the regional policy committee, and
LO	WHEREAS, the charter establishes the subject matter areas for the regional policy
11	committee to be those countywide plans and policies included in the committee's work
12	program, and
13	WHEREAS, the 2017 regional policy committee work program identifies the
14	mental illness and drug dependency evaluation and implementation plans as within the
15	subject matter area for the committee, and
16	WHEREAS, the mental illness and drug dependency evaluation and
17	implementation plans were introduced on August 21, 2017, and the charter and code -
18	mandated timeline would require review and action by December 2017; and
19	WHEREAS, the regional policy committee has between August 2017 and

20	November 2017 received other mandatory referrals that the committee chose to prioritize
21	and expedite due to the necessity of implementing those mandatory referrals in
22	connection with the November 2017 election; and
23	WHEREAS, the regional policy committee does not have time to hear the mental
24	illness and drug dependency evaluation and implementation plans until December 2017
25	and it is the regional policy committee's chair's desire to allow for one additional month
26	of deliberations on these plans, and
27	WHEREAS, the regional policy committee and the council are committed to
28	effective and efficient legislative review processes that respect the charter-mandated
29	legislative process for the review of countywide plans and policies, and
30	WHEREAS, the charter and K.C.C. 1.24.065 establish that the timeframe for
31	review by a regional committee may be extended beyond the one-hundred-twenty-days to
32	such another time as is jointly established by the council and the committee, which shall
33	be confirmed in the form of a motion adopted by the council, and
34	WHEREAS, the regional policy committee voted on November 15, 2017 to
35	request that the Chair introduce a motion requesting the King County council to extend
36	the one-hundred-twenty-day timeframe to one-hundred-sixty days; and
37	WHEREAS, the King County council wishes to grant by motion, that additional
38	time for review;
39	NOW, THEREFORE, BE IT MOVED by the King County Council:
40	The regional policy committee shall have one hundred sixty days from August 21.

- 41 2017 to review and act upon the mental illness and drug dependency evaluation and
- 42 implementation plans.
