NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, May 29, 2018, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2017-0244 (Ordinance 18767) an ordinance amending the King County Code to modify the shoreline development code. The Council adopted Ordinance 18767 at their July 16, 2018 regular meeting.

SUMMARY:

Ordinance 18767 modifies King County Code relating to shoreline management regulations. Substantive changes include clarifications to definitions, permitted alterations to critical areas, alteration exceptions to critical areas/setbacks from critical areas, permitted shoreline modifications, docks and other similar structures, shoreline permit requirements, shoreline nonconformances, procedural requirements and shoreline master program elements.
