Mr. von Reichbauer raised a Point of Clarification regarding the request for a week's delay if the legislation is placed before the Council.

Mr. Ferguson requested clarification on procedure.

Jim Brewer, legal counsel, indicated the motion to relieve the committee is not an incidental motion, and incidental motions are required to be decided without debate. He indicated debate on whether the legislation should be relieved from the committee is in order if it is the will of the Council.

Ms. Hague requested a roll call vote on relieving the Law, Justice, Health and Human Services Committee of Proposed Ordinance 2011-0205.

Mr. Ferguson's motion carried by the following vote: Votes: Yes: 5 - Mr. Dunn, Mr. Ferguson, Ms. Hague, Ms. Patterson and Mr. von Reichbauer No: 3 - Ms. Lambert, Mr. McDermott and Mr. Gossett Excused: 1 - Mr. Phillips *Mr.* Phillips requested that the minutes reflect that had he been present, he would have voted to relieve the committee of Proposed Ordinance 2011-0205.

Mr. von Reichbauer moved to extend a one week courtesy delay and hold Proposed Ordinance 2011-0205 until the July 25, 2011 Council meeting. Seeing no objection, the Chair so ordered.
