She indicated she asked the Congressional delegation for help to ensure that the Corps adopts a workable solution to this issue, and that the members have signed a letter supporting a workable solution that will save taxpayers money. She also spoke with the delegation about funding for Rapid Ride E (Shoreline to Seattle) and Rapid Ride F (Burien to Renton). Both the US House and US Senate Appropriations Committees will consider the Rapid Ride funding soon.
