24. Proposed Ordinance No. 2012-0210

AN ORDINANCE providing for the submission to the qualified electors of King County at a special election to be held in King County on November 6, 2012, of a proposition to support continuation of the regional automated fingerprint identification system program by renewing and replacing authorization of an expiring property tax levy in excess of the levy limitation contained in chapter 84.55 RCW, for a consecutive six-year period, at a first year rate of not more than \$0.0592 per one thousand dollars of assessed valuation for collection beginning in 2013, with subsequent maximum levy collections being increased by the greater of one percent or the percentage increase in the consumer price index as long as that amount does not exceed three percent, for the purpose of funding the continued operation of the regional automated fingerprint identification system and related technology and services, which expand crime scene and arrest identification capabilities for all criminal justice agencies in King County.

This is a dual referral first to the Regional Water Quality Committee and then to the Transportation, Economy and Environment Committee.

This is a nonmandatory referral to the Regional Water Quality Committee under King County Charter 270.30 and KCC 1.24.0651 as an issue that is not a countywide policy or plan but would benefit from interjurisdictional discussion.

This matter had its first reading and was referred first to the Regional Water Quality Committee and then to the Transportation, Economy and Environment Committee.

29. Reports on Special and Outside Committees

Ms. Patterson briefed the Council on the recent Flood Control District/King Conservation District/Water Resources Inventory Areas meeting. There was discussion

regarding the changes in funding for programs that have been historically funded by King Conservation District revenues. Deputy Executive Fred Jarrett moderated the meeting. Sara Hemphill, Executive Director, King Conservation District, briefed the members on two relevant court cases, the KCD budget in 2012 and how the KCD plans to move forward with a new way to raise revenue. The group discussed what they would like the future conservation district programs to look like, and presented their ideas, which included many new ideas for the KCD, such as increasesd opportunities for partnerships.

Ms. Lambert reported on her visit with Masaaki Imai, an internationally renowned expert on LEAN. Ms. Lambert indicated that King County has already implemented 15 LEAN events, with more in process. She also indicated that 200 employees have been involved and participated in the LEAN process.

Mr. Phillilps reported on the Sound Transit Capital Committee. Staff provided a briefing on the work underway with the City of Bellevue on identifying cost savings for east link light rail. Endorsement of the cost savings work plan will be up for consideration at the next Bellevue City Council and Sound Transit Board meetings. The committee also recommended for the Board several contracts.

Other Business

The meeting was convened in Executive Session to consider matters related to ongoing collective bargainng negotiations, as provided for in RCW42.30.140(4).
