Sound Transit has completed an assessment of a transit oriented development at the south 200th site.

Ms. Hague reported on the Eastside Transportation Partnership. She indicated that the members received a presentation on environmental assessment for tolling on I-90 and I-405. There was also discussion on the 2013 legislative agenda.

Mr. Dunn commented with regard to Ms. Lambert's proclamation on human trafficking, indicating that there will be a Metro public service campaign on this issue.
