The participants discussed municipal bonds and Ms. Hague distributed a document regarding NACO's position on the subject. She also made comments on the subject of healthcare and indicated that Washington State has a very aggressive open enrollment process.

Ms. Lambert also made comments on her attendance at the NACO conference. She informed the councilmembers that King County won an award as the fourth best technological county in the U.S. She complimented the KCIT department. She also spoke about cyber security.
