Mr. Upthegrove briefed the members on the last Sound Transit Board of Directors meeting. He reported that the Board approved the final contract for Angle Lake Station in SeaTac. The Board was briefed on the progress of the East Link expansion. He also reported that the Board adopted a resolution allowing for the procurement or lease of 17 parcels in Bellevue for operations and maintenance of light link. The Board received an update on long range planning. He noted that the Board was awarded a grant for the Tacoma Trestle. He also reported that the Board approved to move the Tacoma link alignment plans on to environmental review.

Mr. McDermott briefed the members on the last 4Culture Board meeting. He noted that long time former Board member, Attorney General Bob Ferguson was present. The Board thanked Mr. Ferguson for his years of service on the Board. Mr. McDermott reported on a briefing on the largest collection of public art. He noted that the Board approved the public art plan and the ongoing costs to maintain them.

Mr. von Reichbauer shared with the members that he met the newest Federal Way City Councilmember Lydia Assefa-Dawson, who is the mother of his former intern Caleb Dawson.
