4. Approval of invoices

Mark Hoppen, Executive Director, briefed the committee on the following invoices: King County Water and Land Resources Division (WLRD) (March 2014 operating \$790,968.77; March 2014 capital \$1,033,115.27): Inslee Best (April 2014 \$9,779.50); Francis and Co. 5. Resolution adopting objectives for Provisional Levels of Protection for the Green River System-Wide Improvement Framework

Jennifer Knauer, WLRD, reported on the timeline for the project and on the provisional level of protection goals that have been proposed. She reiterated the stakeholder meetings that have occurred, reviewed a map showing the various levels of protection and answered questions of the committee.

There was a suggested amendment on line 58 after "'C," to add "or increase the level of protection to a higher flow rate up to and including a maximum provisional flow rate of 18,800 cfs." There was a suggested amendment on line 49 to delete "and" and insert "and/or" and on line 50 delete "or both". Boardmember Upthgrove moved the amendments as stated by the clerk. The motion passed unanimously.
