Councilmember Hague reported on the National Association of Counties Conference (NACO). She indicated that Vice President Joe Biden kicked off the general session with a very articulate discussion of how policies that will be in front of Congress and the White House address the well-being of the middle class. Councilmember Hague attended NACO's Transportation Committee meeting. The Committee discussed reauthorizing Map 21 and the highway trust fund.

Councilmember Lambert also reported on the National Association of Counties Conference. The conference covered behavioral health in the juvenile justice system, the health of youth, the national insurance reform act, emergency resolutions to reauthorize the juvenile justice system and work on sex trafficking of children. Councilmember Lambert reported that a policy statement was voted on urging the federal government to suspend rather than terminate Medicaid when people are in jail.

Councilmember McDermott reported on the Sound Transit Board meeting. The Board heard reports from the Diversity Oversight Committee regarding apprenticeship and pre-apprenticeship training goals and the inclusion of women and minority owned businesses in our projects. The Board also heard a report on the Northgate Link Extension and a system planning schedule overview for a possible Sound Transit 3 public vote. Councilmember McDermott indicated that one item was referred back to committee for more work regarding instituting Wi-Fi in trains.

Councilmember Phillips reported on his attendance at the recent Cedar River Council meeting. The council discussed the channel migration zone study, landslide mapping study and received a presentation from a citizen in the area regarding large woody debris. Councilmember Phillips indicated that this year marks the 20th anniversary of the Cedar River Council. There will be a celebration of the 20th year in May.

Councilmember Hague reported on the Economic Development Council quarterly meeting. The Council voted in board members, introduced staff and developed goals that will attract new members.
