4. Proposed Ordinance No. 2015-0229

AN ORDINANCE relating to a task force to make recommendations on the creation of a King County immigrant and refugee commission.

Amy Tsai, Council staff, briefed the Committee and answered questions from the members.

Councilmember Gossett moved striking amendment S1.

Councilmember Lambert moved amendment 1 with an oral amendment to lines 24, 29 and 33, changing "shall include" and "shall examine" to "may consider". Councilmember Dembowski moved to amend lines 11 and 12 to retain "access to county services" and add "and" before "opportunities". Ms. Lambert accepted the amendment as friendly.

Councilmember Lambert withdrew Amendment 1 and moved Amendment 1.A to include the same oral amendments made to amendment 1. Councilmember Hague made an oral amendment to amendment 1.A to strike lines 50 and 51 entirely. Amendment 1.A as amended passed unanimously.

Striking amendment S.1 as amended passed unanimously.

A motion was made by Councilmember Gossett that this Ordinance be Recommended Do Pass Substitute. The motion carried by the following vote:
