#### 5. Proposed Ordinance No. 2015-0275

AN ORDINANCE providing for the submission to the qualified electors of King County at a special election to be held in King County on November 3, 2015, a proposition to amend Section 898 of the King County Charter and add a new Section 265 to the King County Charter, establishing a charter-based civilian office of law enforcement oversight, providing the office with appropriate authority to carry out its duties and establishing a charter-based citizen advisory committee on law enforcement oversight, making the county executive, in consultation with the county sheriff, the county's bargaining agent concerning civilian oversight of law enforcement; and appointing a committee to write the voters pamphlet statement for the November 3, 2015, special election.

Nick Wagner, Council staff, briefed the Committee and answered questions from the members. John Urquhart, King County Sheriff, and Carl Cole, Puget Sound Police Managers' Association President, addressed the Committee and answered questions from the members. Patti Cole-Tindall, Office of Law Enforcement Oversight, Interim Director; and Director of Labor Relations; and Kymber Waltmunson, King County Auditor, addressed the Committee.

Councilmember Phillips moved striking amendment S1. Three oral amendments to striking amendment S1 were proposed: line 22, change "analysis of internal" to "analyze internal"; line 77, delete "is established"; and line 99, replace "director of the records, elections and licensing services division" with "county director of elections". Mr. Phillips accepted the amendments as friendly. Amendment S1 passed by a vote of 8 Ayes and 1 No (Lambert).

Councilmember Phillips moved title amendment T1. Amendment T1 passed unanimously.

This matter was expedited to the July 20, 2015, Council agenda.

A motion was made by Councilmember Phillips that this Ordinance be Passed Out of Committee Without a Recommendation. The motion carried by the following vote:
