#### 3. Approval of Minutes of December 14, 2015

#### 4. Board of Appeals Clerk hiring confirmation

Charles Brydon, chair, Board of Appeals and Equalization, introduced Michelle Geiger, who is the Board's choice for Clerk/Manager, and answered questions of the committee.

Carolyn Busch, Chief of Staff, answered questions of the committee.

Tracy Calderon, Human Resources Coordinator, reported on the process: there were 20 applicants, five were forwarded by the staff interview team of Neal Cook, current Board clerk/manager; Ms. Busch; Janine Weihe, Council Administrative Officer; and Amy Calderwood, Ombudsman. The staff team forward three applicants to the Board, who interveiwed them. The Board voted to extend an offer of employment to Ms. Geiger, who answered questions of the committee.

Councilmember Gossett moved that the committee concur with the Board of Appeals decision to hire Michelle Geiger as the Board of Appeals Clerk/Manager at pay range 128, step 6, of the 2016 Legislative Branch Salary Schedule, to begin on a date mutually agreed-upon by Neal Cook and Mrs. Geiger.
