Councilmember Balducci also reported that the Sound Transit Board voted on a draft system plan for Sound Transit Phase 3. The plan includes light rail extensions, bus rapid transit extensions and additional system planning. Councilmember Balducci encouraged the public to view the plan on www.soundtransit.org. Public comments will be accepted until April 29 and will help determine what will be on the ballot this year.
