8. Budget Key Issues and Direction: Mid-year budget resolution and 2017 Budget Direction to Advisory Committee

Ms. Lund reported on two budget-related issues: (1) the midyear budget, which may include carryover funding and funding for flood damage from this winter's storm, an increase in the accounting contract for this year, funding for the Lower Green River corridor plan and EIS funding and an increase in the funding for the Countyline project, which is expected to be completed earlier than anticipated, and (2) possible direction to the Advisory Committee for review of the 2017 budget, including the property tax levy amount, a strategy for handling predictable emergency repairs and project delivery. She also reported on the interim SWIF and that there will be an update to the 2018 flood hazard plan in 2018.

Boardmember Lambert asked that equipment needs be considered in developing the 2017 budget.

> Mr. Isaacson reported on the the Countyline project, the Cedar River sediment removal project in Renton, the Blackriver sediment removal and pump replacement project and the Dykstra levy repair. He reported on WLRD workshop on placement of large woody debris and a community forum with consulting agencies on upcoming projects. The flood center will be open during the Cascadia Rising emergency exercise. WLRD also continues with the landslide mapping project.
