BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

SECTION 1. The county executive is hereby authorized to execute, substantially

in the form of Attachment A to this ordinance, an interlocal agreement between Multnomah County and King

County for program evaluation and grant writing services.
