AN ORDINANCE adopting the revision of voting precincts of King County for the year 2014.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to K.C.C. 1.12.010.E. and RCW 29A.16.040, the 2014 revisions and alterations to the King County voting precincts as contained in Attachments A, B, C, D, E, F, G, H and I to this ordinance are adopted and shall constitute an

amendment to the official list of county voting precincts maintained by the department of elections.
