A MOTION acknowledging receipt of a report on the sustainability of the

employment and education resources fund funding model as required by the

2013/2014 Biennial Budget Ordinance, Ordinance 17476, Section 105, Proviso

P1, as amended.

WHEREAS, Ordinance 17696, Section 16, and Ordinance ____ (Proposed Ordinance 2014-0224),

Section 30, amended the 2013/2014 Biennial Budget Ordinance, Ordinance 17476, Section 105, which

appropriated the employment and education resources fund 2013/2014 biennium budget, by adding and

amending Proviso P1, and

WHEREAS, Ordinance 17476, Section 105, Proviso P1, as amended, concerned \$500,000 that shall not

be expended or encumbered until the executive transmits a report on the sustainability of the employment and education resources fund funding model and a motion that acknowledges receipt of the report, and the motion is passed by the council;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The council acknowledges receipt of the report, as described in this motion, and releases \$500,000 for expenditure of the \$500,000 that is the subject of the 2013/2014 Biennial Budget Ordinance, Ordinance 17476, Section 105, Proviso P1, as amended.
