BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The collective bargaining agreement negotiated by and between King County and

Washington State Council of County and City Employees, Council 2, Local 2084SC-S (Superior Court -

Supervisors (Wages Only)) representing employees in the King County superior court, which is Attachment A

to this ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from January 1, 2015, through and including December 31, 2016.
