AN ORDINANCE approving and adopting the memorandum of agreement

regarding "Employee Referral Recognition Pilot Program" negotiated by and

between King County and Amalgamated Transit Union, Local 587 (Department

of Transportation - Transit) representing employees in the department of

transportation; and establishing the effective date of said agreement.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The memorandum of agreement regarding "Employee Referral Recognition Pilot

Program" negotiated by and between King County and Amalgamated Transit Union, Local 587 (Department of Transportation - Transit) representing employees in the department of transportation, which is Attachment A to this ordinance, is hereby approved and adopted by this reference made a part hereof.

SECTION 2. Terms and conditions of said agreement shall be effective from ratification of the memorandum of agreement, through and including December 31, 2017.
