AN ORDINANCE relating to the reallocation of capital improvement projects in

the conservation futures and parks capital funds; making a supplemental

appropriation of \$0 to the conservation futures fund and \$0 to parks capital fund;

and amending the 2017-2018 Biennial Budget Ordinance, Ordinance 18409,

Section 132, as amended, and Attachment A, as amended.

#### PREAMBLE:

The King County conservation futures tax levy is collected from a dedicated portion of property taxes from throughout King County and its cities, for purchase of natural resource lands and passive open space.

This ordinance reallocates the King County conservation futures tax levy appropriation to

various projects as recommended by the conservation futures citizens committee as a result of their annual review.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. This ordinance makes a supplemental appropriation of \$0 to the conservation futures fund and \$0 to parks capital fund.

SECTION 2. Ordinance 18409, Section 132, as amended, is hereby amended by adding thereto and inserting the following:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment A to this ordinance.
