AN ORDINANCE relating to the veterans and family and human services appropriations; making a supplemental appropriation to the department of community and human services of \$1,592,916 to the veterans and family levy fund and \$671,946 to the human services fund; and amending the 2017-2018 Biennial Budget Ordinance, Ordinance 18409, Sections 76 and 77, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. From non-general funds there is hereby appropriated a net total of \$1,592,916 to the veterans and family levy fund and \$671,946 to the human serices fund.

There is hereby appropriated \$1,592,916 to the veterans and family levy fund.

There is hereby appropriated \$671,946 to the human services fund.
