NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council on the 15th day of September, 2020, at 1:00 p.m., to consider adoption of Proposed Ordinance 2020-0150 which will enable the county to sell the surplus vacant parcel of land to the City of Kirkland for open space and watershed improvement purposes. The public hearing is planned to either be held at the King County Courthouse, 516 3rd Avenue, Room 1001, Seattle, Washington; or the hearing may be required to be held remotely to comply with the Washington State Governor's Declaration 20-28 (or as amended) regarding the Open Public Meetings Act.

### SUMMARY

The proposed ordinance would allow the executive to sell the surplus Road Services Division property located in County Council District One at, 14256 100th Ave NE to the City of Kirkland. The following is a legal description of the area:
