Mr. McDermott reported on the Sound Transit Board meeting. The members received a financial report highlighting the impacts of rising gas and construction costs. They also received an update on the ongoing work in the south corridor realignment study. Mr. McDermott indicated there was a unanimous vote to authorize the purchase and sales agreement with the Port of Seattle for a 1.1 mile segment of former rail line as easements for high capacity transit. This purchase will allow east link to move forward.

Ms. Hague briefed the Council on the Growth Management Planning Council, a regional group of elected officials who represent the cities and King County, dealing with land use related issues. She commented there was a public hearing on changes to the comprehensive plan at the last meeting, and there was a chapter by chapter review taking comments into consideration. The comments will serve as a basis on future decisions.
