3 amending Ordinance 12076, Section 9, as amended, and
4 K.C.C. 4.08.015 and adding new sections to K.C.C. chapter
5 4.08.

PREAMBLE:

8

WHEREAS, the Metropolitan King County council has a long
9 history of responsible stewardship of the public's money, and;

WHEREAS, the council passed Motion 5888 in December of 1983
12 which created a number of financial policies including requirement for
13 maintenance of minimum levels of fund balance in the county's current
expense fund, and;

WHEREAS, the council passed Motion 7020 in November of 1987
16 which dedicated a portion of additional sales tax revenues to the creation
of a sales tax reserve fund to be used for financial emergencies, and;

17 WHEREAS, the council passed Motion 8352 in July of 1991 that
18 reaffirmed its intent that the sales tax reserve fund be used for financial
19 emergencies, and;

20 WHEREAS, during the budget process to adopt the 1992 budget,
21 the executive's proposed financial plan proposed spending the sales tax
22 reserve funds, and;

23 WHEREAS, in response, the council passed Motion 8446 in
24 October of 1991 once again affirming its intent that the sales tax reserves
25 only be used in financial emergencies, and;

26 WHEREAS, these sound financial policies have led the major
27 credit rating agencies to award the county's limited tax general obligation
28 debt with the highest ratings, and;

29 WHEREAS, the county's general fund includes a number of sub-
30 funds, including the current expense, inmate welfare, children and family
31 set-aside, and sales tax reserve, and;

32 WHEREAS, these sub-funds do not increase the transparency of
33 county finances and serve only as accounting devices, and;

34 WHEREAS, the council strongly supports transparent and open
35 government, and;

36 WHEREAS, the third quarter 2007 management and budget report
37 indicated that the actual amount in the sales tax reserve on December 31,
38 2006 was \$15,704,186, and;

39 WHEREAS, the third quarter 2007 management and budget report
40 indicated that the actual amount in the children and families set-aside
41 reserve on December 31, 2006 was \$3,890,503, and;

42 WHEREAS, with adoption of the 2007 annual budget, the county
43 council created the Financial Policies Advisory Task Force to examine
44 county financial policies, and;

45 WHEREAS, the Financial Policies Advisory Task Force
46 recommended the creation of a rainy day reserve fund, and;

47 WHEREAS, the Financial Policies Advisory Task Force also
48 recommended that the general fund sub-funds be segregated into their own
49 funds,

50 NOW THEREFORE

51 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

52 NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 4.08 a
53 new section to read as follows:

54 A. There is hereby created the Rainy Day Reserve Fund for the purpose of
55 accumulating revenues to be available for emergencies, as defined in subsection B in this
56 section of this ordinance. This fund shall be a first tier fund, fully invested for its own
57 benefit. The director of the office of management and budget shall be the fund manager.

58 B. The Rainy Day Reserve Fund shall be used in the event of an emergency, as
59 declared by a vote of the County Council for the following purposes:

60 1. Maintenance of essential county services in the event that current expense
61 fund revenue collections in a given fiscal year are less than ninety-seven percent of
62 adopted estimates.

63 2. Payment of current expense fund legal settlements or judgments in excess of
64 the county's ability to pay from other sources.

65 3. Catastrophic losses in excess of the county's other insurances against such
66 losses.

67 4. Other emergencies, as determined by the council.

68 NEW SECTION. SECTION 2. There is hereby added to K.C.C. chapter 4.08 a
69 new section to read as follows:

70 A. There is hereby created the Children and Families Services Fund for the
71 purpose of supporting services throughout the county that support community, family or
72 children's programs. This fund shall be a first tier fund, fully invested for its own benefit.
73 The director of the department of community & human services shall be the fund
74 manager. The policies set forth below shall govern the management of the fund.

75 B. Revenues currently accruing to the Children & Family set-aside shall now
76 accrue to the Children and Families Services Fund.

77 C. Children and family set-aside fund balances as of December 31, 2007 held in
78 the county's general fund shall be transferred to the Children and Families Services Fund.

79 SECTION 3. Ordinance 12076, Section 9, as amended, and K.C.C. 4.08.015 are
80 each hereby amended to read as follows:

- 82 B. The following shall also be first tier funds:
- 83 1. All funds now or hereafter established by ordinance for capital construction
- 84 through specific road improvement districts, utility local improvement districts or local
- 85 improvement districts. The director of the department of transportation shall be the fund

86 manager for transportation-related funds. The director of the department of natural
87 resources and parks shall be the fund manager for utility-related funds.

88 2. All county funds that receive original proceeds of borrowings made under
89 Chapter 216, Washington Laws of 1982, as now existing or hereafter amended, to the
90 extent of the amounts then outstanding for the borrowings for that fund. For purposes of
91 this subsection, the director of the county department or office primarily responsible for
92 expenditures from that fund shall be the fund manager.

93 3. Any other fund as the council may hereinafter prescribe by ordinance to be

94 invested for its own benefit. County funds shall be treated as provided in K.C.C.
95 4.10.110 unless a designation is made by the council.




