1	AN ORDINANCE relating to the annexation of an area of
2	land known as annexation area 2003-2 into the Val Vue
3	Sewer District for the purpose of providing sewer service
4	for future development.

7	STATEMENT OF FACTS:
8	1. A notice of intention proposing the annexation of an area known as
9	annexation area 2003-2 into the Val Vue Sewer District for the purpose of
10	providing sewer service for future development was filed with the county
11	council on October 25, 2004.
12	2. Val Vue Sewer District has found the petition for transfer to be
13	sufficient and has concurred with the proposed transfer in Resolution No.
14	2004-8, passed on September 7, 2004.
15	3. Val Vue Sewer District filed a Determination of Nonsignificance on
16	the proposed annexation dated August 25, 2004.
17.	4. The utilities technical review committee recommended county council

18	approval of the proposed annexation.
19	5. The county council held the legally required public hearing and has
20	considered the criteria in RCW 57.02.040.
21	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
22	SECTION 1. The annexation of an area known as annexation area 2003-2 into
23	Val Vue Sewer District for the purpose of providing sewer service for future
24	development described in Attachment A of this ordinance is approved. Approval of this
25	proposed annexation is consistent with RCW 57.02.040.
26	SECTION 2. Val Vue Sewer District is the appropriate entity to serve the area
27	proposed to be annexed.

VAL VUE SEWER DISTRICT 8TH AVENUE SOUTH ANNEXATION (ANNEXATION 2003-2) "EXHIBIT A" LEGAL DESCRIPTION

LOCATED IN SECTION 8, TOWNSHIP 23 NORTH, RANGE 4 EAST, WM., IN KING COUNTY, WASHINGTON.

BEGINNING AT THE INTERSECTION OF THE CENTERLINE OF SOUTH 116TH STREET AND THE EASTERLY MARGIN OF SECONDARY STATE HIGHWAY NO. I-K;

THENCE EASTERLY ALONG SAID CENTERLINE OF SOUTH 116TH STREET TO THE NORTHERLY EXTENSION OF THE EAST LINE OF LOT 1, BLOCK 16 OF HILLMAN'S GARDEN TRACT AS RECORDED IN VOLUME 11 OF FLATS, PAGE 6, RECORDS OF KING COUNTY, WASHINGTON;

THENCE SOUTHERLY ALONG SAID NORTHERLY EXTENSION AND ALONG THE EAST LINE OF LOTS 1, 2, 3, 4, 5, 6, 7, 8, AND 9 OF SAID PLAT TO THE INTERSECTION WITH A LINE RUNNING NORTH 89 DEGREES, 07 MINUTES, 20 SECONDS WEST FROM A POINT 120 FEET NORTH OF THE SOUTHEAST CORNER OF LOT 11 OF SAID PLAT:

THENCE EASTERLY ALONG SAID LINE TO THE WEST LINE OF THE EAST 155 FEET OF SAID LOT 11;

THENCE SOUTHERLY ALONG SAID WEST LINE AND ITS SOUTHERLY EXTENSION TO THE SOUTH LINE OF SOUTH 120TH STREET;

THENCE WESTERLY ALONG SAID SOUTH LINE TO THE INTERSECTION WITH THE EASTERLY MARGIN TO SAID SECONDARY STATE HIGHWAY NO. 1-K:

THENCE NORTHERLY ALONG SAID EASTERLY MARGIN TO THE INTERSECTION WITH THE CENTERLINE OF SOUTH 116TH STREET AND THE TRUE POINT OF BEGINNING.
