NOTICE IS HEREBY GIVEN, that a public hearing will be held before the Metropolitan King County Council, Room 1001, King County Courthouse, Seattle, Washington, on the 24th day of June, at 1:30 p.m., to consider adoption of Proposed Ordinance 2013-0155, authorizing the executive to execute necessary documents between King County and the City of Shoreline for the sale of real property purchased by King County for the use by the King County Department of Transportation, Roads Services Division.

**SUMMARY**

The City of Shoreline is acquiring a 2.87 acre surplus parcel commonly referred to as the Brugger's Bog facility from the King County Roads Services Division. The site was previously used as the North maintenance site for the Roads Services Division. After the City of Kirkland annexed the Juanita/Kingsgate/Finn Hill areas, the Roads Services Division declared the property surplus to its needs and an agreement to sell the site to the City of Shoreline was developed.

This property is located in the city of Shoreline at 19547 25th Avenue Northeast in District 1. Shoreline plans to continue to use the property for maintenance purposes.

The King County Council will consider an ordinance on June 24, 2013, approving the sale of the real property.
