NOTICE IS HEREBY GIVEN that a Notice of Intention has been filed with the King County Council relating to the annexation of approximately 2.33 acres of land into the Covington Water District, known as the Station by Vintage Annexation, for the purpose of water service. A public hearing before the Metropolitan King County Council will be held at the King County Courthouse, 516 3rd Avenue Room 1001, on Tuesday, July 12, 2022, at 1:00 p.m.; remote public testimony on Zoom will be accepted. Information on the public hearing and how to submit public testimony can be found at this website: https://www.kingcounty.gov/council/committees/full_council.aspx.

A description of the proposed area to be annexed is as follows: All that certain real property situated in the County of King, State of Washington, being a portion of the Northwest one-quarter of the Southwest one-quarter of Section 36, Township 22 North, Range 5 East, Willamette Meridian, being described as follows:

BEGINNING at the Northeast corner of the said Northwest one-quarter of the Southwest one-quarter of Section 36, Township 22 North, Range 5 East, Willamette Meridian;

THENCE along the North line of the said Northwest one-quarter of the Southwest one-quarter of Section 36, North 89°07'15" West 451.98 feet to the northeasterly line of Covington Way SE;

THENCE along said northeasterly line of Covington Way SE the following two courses and distances:

South 45°23'30" East 240.24 feet and South 38°10'00" East 322.43 feet to the northwesterly line of SE Wax Road;

THENCE along said northwesterly line of SE Wax Road, North 41°10'02" East 116.29 feet to the East line of the said Northwest one-quarter of the Southwest one-quarter of Section 36;

THENCE along said East line, North 00°53'31" East 327.78 feet to the said **POINT OF BEGINNING** of this description.
