**SUBJECT**

Public Records Disclosure Update

**SUMMARY**

This briefing is a follow-up to the briefings presented at the committee's April 12 and 26 meetings (2011-B0065 and 2011-B0076) concerning county agency reports on their responses to public record disclosure requests and their implementation of the requirements contained in Ordinance 16679.

**BACKGROUND**

Ordinance 16679, adopted by the Council on 12 October 2009, amended chapter 2.12 of the county code ("Maintenance of Permanent Records") in response to the Washington Attorney General's model rules and comments on public records compliance (WAC 44-14). Chapter 2.12 governs the procedures for county agencies to follow in responding to public record requests.

The following summary of the relevant provisions of Ordinance 16679 was included in the most recent staff report and is repeated here for the committee's convenience.

**Required Reports on Responses to Public Record Requests**

Section 2.12.300 of the county code, which was added by Ordinance 16679, provides in part:

A.1. No later than April 1 of each year, the public records officer of each county agency<sup>1</sup> shall submit to the county council a report on the agency's

<sup>1</sup> "Agency" is defined in section 2.12.005 of the county code to comprise the executive branch, the legislative branch, the department of public safety, the department of assessments, the office of the prosecuting attorney, the department of elections, the forecast council and office of economic and

performance in responding to public record requests during the preceding calendar year. The report shall include, at a minimum, a listing of all requests that either were closed during the preceding calendar or remained open at the end of the preceding calendar year, including, for each request:

- a. the name of the requestor;
- b. a summary of the request;
- c. the date the request was received; and
- d. the date the request was closed, if it has been closed.

### **Litigation Reports Required of the Prosecuting Attorney**

Section 27(B) of Ordinance 16679 (codified as KCC § 2.12.300(B)) requires the Prosecuting Attorney to report, on January 15 and July 15 of each year, on all pending lawsuits alleging that the county has violated RCW Chapter 42.56 (the state public records act), including the name of the case, the court in which it was filed, the date on which it was filed, the case number, a brief summary of the claims made against the county, and the current case status.

### **Required Reports on Implementation of Ordinance 16679**

Section 28 of Ordinance 16679 required each county agency to submit a report by 16 July 2010 describing “the steps the public records officer has taken to implement this ordinance, including, but not limited to, the requirements in sections 20.A and 21.D.1 of this ordinance.”

Section 20.A (codified as KCC § 2.12.230(A)) provides:

Each agency shall appoint a public records officer and shall identify the officer in a way reasonably calculated to provide notice to the public, including posting, at the agency's public service counters, if any, and on its website, the officer's name, office address, telephone number, fax number and email address. Each agency shall include on its website home page a link to the web page on which the agency provides this contact information and instructions on how to make a public record request.

Section 21.D.1 (codified as KCC § 2.12.240(D)(1)) provides:

A person wishing to inspect or copy public records of an agency is encouraged to make the request in writing on the agency's request form, which shall be created and maintained by the agency's public records officer and made available on the agency's website. The agency request form shall:

- a. recite that inspection of records is free, provide the per-page charge for standard photocopies and indicate that the requestor may

financial analysis, the board of appeals, and the personnel board. Superior Court and District Court are explicitly excluded from the definition of agency.

inspect the records, receive a copy of the records or inspect the records first and then select records to copy;

b. prompt the requestor to provide contact information including name, phone number, mailing address and email address if available;

c. prompt the requestor to identify the public records adequately for the public records officer or designee to locate the records; and

d. prompt the requestor to provide the date and time of day of the request.

### **COMPLIANCE WITH ORDINANCE 16679**

**Re: Public Disclosure Report for Calendar Year 2009 under K.C.C. 2.12.300**

Dear Ms. Noris:

Enclosed please find a copy of the King County Sheriff's Office report regarding the public disclosure requests the Sheriff's Office closed in calendar year 2009. There are two separate spreadsheets: one from the Legal Unit and one from the Records Unit. The Legal Unit and Records Unit record their data differently. In 2009, the Legal Unit of the Sheriff's Office closed **742** requests. The 742 number represents 742 requests by individual requestors on discrete dates. It does not reflect the number of documents requested by the requestor or provided by the unit. In 2009, the Records Unit provided **17,503** case reports to requestors. It does not reflect the actual number of requestors. The Records Unit records the number of documents requested, even if one requestor requested more than one document. To assist the Council in understanding the information, the following is a summary of how the Sheriff's Office handles public disclosure requests.

Both the Sheriff's Office Records Unit and the Sheriff's Office Legal Unit respond to public disclosure requests. The Records Unit manages the Office's central record management system for all "case" reports, including traffic collision reports, criminal cases investigated by our office, civil problems, mental complaints, etc. The Records Unit responds to requests for documents for all case reports. The Legal Unit responds to public disclosure requests for everything other than the actual case reports. Typical documents requested through the Legal Unit include 911 tapes, photographs, Computer Aided Dispatch Reports, personnel files, internal investigation unit files, training records, officers' notes, video recordings, administrative review documents and agency, emails, correspondence, MARR diagrams, etc. The Records Unit records are available to the unit within the unit itself either through the electronic record management system or because they are delivered in hard copy to the unit, such as copies of citations and traffic collision reports. The Legal Unit does not have direct access to the majority of documents

requested and works with other units within the Sheriff's office to obtain documents, such as the communications center, photo lab, training unit, personnel unit, and internal investigation unit.

The Records Unit has four full time line staff FTEs predominately dedicated to responding to public disclosure requests. In addition there is a public disclosure supervisor, a "scanner", a records analyst, and other "support" staff who devote part of their function to public disclosure. The manager of the entire Records Unit, which also performs multiple other functions, is also a public records officer for the Sheriff's Office. The Legal Unit has three full time line staff that devotes a substantial portion of their time to public disclosure as well as myself, the supervisor of the Legal Unit. In 2003, the Legal Unit had 1 legal advisor and 1 full time FTE to support all the functions of the Legal Unit, which are varied. Largely due to increase in public disclosure, the unit has added to two full time FTES, scanning machines, and redacting software to assist the agency in responding to public disclosure requests.

The Legal Unit started an internal tracking mechanism a few years ago to try to track and understand the source of the increase in public disclosure requests. The Legal Unit system is "requestor" based, that is we organize the records by the name of the requestor. The Document attached labeled "Document Requests Closed in 2009, King County Sheriff's Office Legal Unit," references the public disclosure requests closed by the unit in 2009. The Summary Chart listing the Requestor Category includes a general breakdown of the category of requestor. The first row, "Agency" includes requests for documents from outside Agencies. Those requests for documents may or may not be specifically "labeled" public disclosure requests. Consequently, we have not included those requests in the itemized list of public disclosure requests provided but we do keep track of them predominately to assist us with keeping track of our work, and to track the total volume of requests for document production being handled in the unit.

The Legal Unit "closed" a total of 742 requests (including agency requests) in 2009. Each request may contain a request for one, a few, or numerous documents. For example, we may just get a request for 911 tapes, a computer aided dispatch report or photographs. Or we may receive a request for personnel files, internal investigation unit files, training records, and "any and all" documents concerning a particular person or case. The Legal Unit does not "count" each individual document that we have to provide, we only count the requests sent in by a requestor on a certain date. If the requestor asks for one or hundreds of documents, we only count that as one "request." The 742 requests are logged by requestor and do not reflect the complexity of each request. The majority of our documents must be read and reviewed for mandatory or discretionary redactions, such as non-conviction data, names and identifying information of child victims of sexual abuse, social security numbers of citizens, etc.

In contrast, the Records Unit is organized around its record based management system, which is a case number based system. Public Records requests are cataloged and stored under the incident number to which they relate, rather than by requestor. The sheer volume of requests has thus far dictated this organizational structure. In 2009, the

Records Unit provided 17,503 “case reports” in response to public disclosure requests, which are 1458 closed requests per month on average. As you can see from the attached spreadsheet, the Records Unit may process and close 25 to over 200 requests per day. The 17,503 “closed” reports do not reflect individual requests, but the number of case reports prepared and provided in response to the requests. So for example, the “256” closed reports provided on January 5, 2009 may have been provided to substantially fewer requestors, such as individuals and insurance companies who, in one request, ask for numerous reports. The Records Unit log also does not reflect the amount of staff time devoted to retrieving, reviewing, redacting and responding to a particular request.

Thus far, the Records Unit is not devoting administrative staff time to manage a separate stand alone electronic spreadsheet to individually log details concerning the requests, such as requestor and summary of request. To do that would require a substantial amount of staff time dedicated to data entry and updating entries. The Records Unit reports however, that the majority of requests for case records are made by citizens requesting their individual traffic collision reports, or case reports when they are victims of crime, or insurance companies requesting the case reports for purposes of processing insurance claims. In addition, there is some overlap between the Records Unit requests and Legal Unit requests because a single request handled by the Legal Unit (for example, 911 tapes and photographs) may also be handled by the Records Unit to provide the associated case reports.

The Manager of the Records Unit is examining various options for managing, tracking and logging public disclosure requests for the unit. One option presented at a recent public records conference is a web-based model “i-compass” which may have features that would improve the public’s access to public records and our ability to track records. The “discounted” rate to initially purchase the program is several thousand dollars (approximately \$6,000 assuming a number of agencies purchase it.) However, the ongoing “maintenance rate” is substantially higher. That cost is prohibitively high for our agency. The Public Records Officer for the entire county is looking at the possibility of purchasing such as a system for the entire county to determine the benefits of the program and potential cost reductions associated with economies of scale. On the other end of the spectrum, the Records Unit could take staff time to devote to creation of the tracking system. Under either approach however, staff time has to be devoted to the sole task of inputting and updating the data related to the request. That time, and the cost of it, is not insubstantial when an agency is processing thousands of requests.


As you can see from the Legal Unit’s log, we receive requests from a variety of requestors. The Public Records Act prohibits agencies from responding differently to requestors and thus discourages “asking” why a request is being made and therefore our office rarely asks those questions. Nonetheless, certain documents are available to certain requestors that are not available to the public at large, such as victims seeking civil redress, the subject of the record, or their attorneys. Consequently in an effort to assist the requestor in obtaining documents to which they are entitled, the reason for the request may be discussed. In other cases, the reason for the request is fairly self-evident. We receive a fairly large number of requests from attorneys for example, who are

representing criminal defendants in criminal cases, or civil attorneys representing clients in civil cases such as car accidents or divorces. We also receive requests from insurance companies, private parties and the media. Of the 742 requests closed last year, only 44 were media requests.

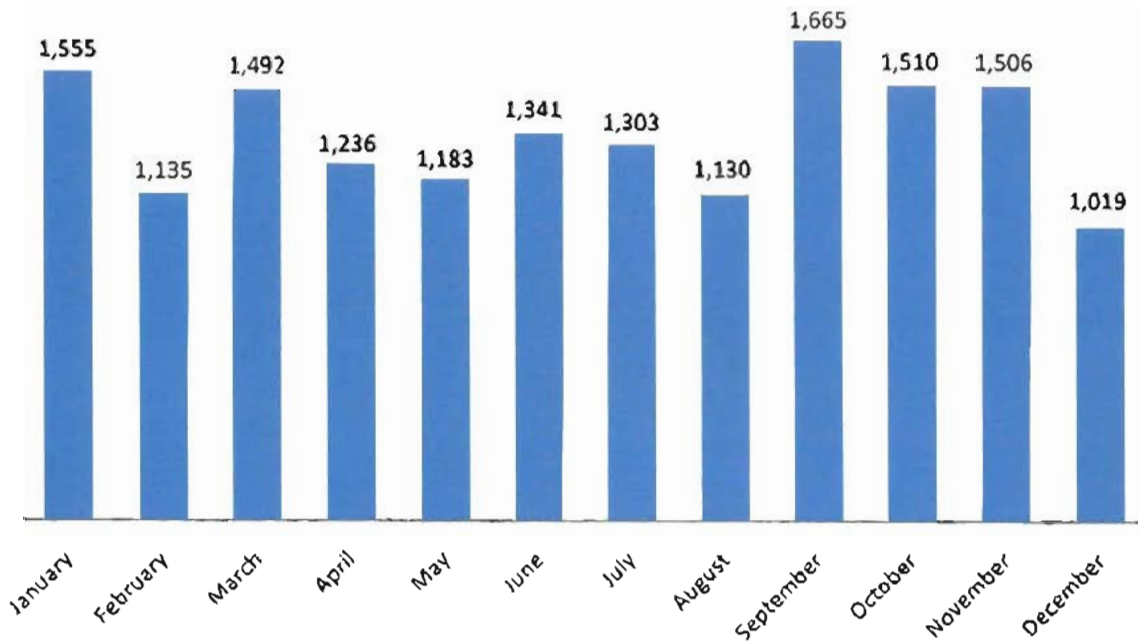

### **2010 Report on Public Disclosure**

Enclosed please find a copy of the King County Sheriff's Office report regarding the public disclosure requests the Sheriff's Office closed in calendar year 2010. The report includes the following documents:

1. A table entitled Public Disclosure Requests Closed in 2010 in the King County Sheriff's Office Legal Unit.
2. A table that identifies the type of requestor who made requests to the Legal Unit in 2010.
3. A chart from the Records Unit that indicates the number of requests closed monthly in the Sheriff's Office Records Unit.
4. A daily tabulation from the Records Unit of the number of requests closed each day of the year for 2010.

Both the Legal Unit and the Records Unit in the Sheriff's Office respond to public disclosure requests. In 2010, the Legal Unit of the Sheriff's Office closed 925 requests. In 2010, the Records Unit processed 16,075 case reports in response to public disclosure requests.

The Records Unit manages the Office's central record management system for all "case" reports, including criminal cases investigated by our office, civil problems, mental complaints, etc. The Records Unit responds to requests for documents for all case reports. The Legal Unit responds to public disclosure requests for everything other than the actual case reports. Typical documents requested through the Legal Unit include 911 tapes, photographs, Computer Aided Dispatch Reports, personnel files, internal investigation unit files, training records, officers' notes, video recordings, administrative review documents and agency, emails, correspondence, MARR diagrams, etc.

### **Implementation of Ordinance 16679 Section 20.A and 21.D.1**


The Sheriff's Office accepts public disclosure requests through whatever medium the requestor desires to use (in writing, via email, fax, in-person, or via telephone). The first page of our website has a link to public disclosure and the public disclosure page advises requestors how to make requests and provides contact information, an on-line request form, and an on-line request system.

In 2010, the Sheriff's Office entered into a contract with "I-Compass" which is a web-based on line method for the public to make public disclosure requests. We entered into the contract in July and the spent several months working with I-Compass to develop the site for the Sheriff's Office. Testing of the system began in October and we started implementation of it in December. I-Compass allows the public to make public disclosure requests electronically 7 days a week, 24 hours a day, 365 days a year. In addition to creating an on-line system for the public to use we hope to realize operational benefits from the system. First, it will be the "tracking system" for both the Records and the Legal Unit. It is increasing communication between the Records unit and the Legal unit about the status of each unit's response to respective portions of the same request. The "reporting" function is not as flexible as the Legal Units former ACCESS database but we are working on improving its functionality. A major consideration in any tracking system and that includes I-Compass is the amount of time it takes staff to enter tracking data and comments. That time is considerable for both units but will obviously markedly increase in the Records unit who processes thousands of requests a year.

Council staff pointed out that the Sheriff's Office website does not provide information that requestors can inspect documents for free. We will correct that error. Otherwise we have implemented Section 21.D.1.
