SUMMARY
The King County Council has concluded discussions with the Tribe regarding the transfer of the roads properties to the Tribe.
The King County Council will consider an ordinance on January 23, 2012 approving the transfer to the Tribe.

The transfer agreement provides for King County to transfer ownership of the roads related property to the Tribe.

Following the transfer, the Tribe shall assume ownership and full and complete responsibility for the operation, maintenance,

repairs, and any subsequent improvements to the properties and facilities.
