1 **STRIKING AMENDMENT TO PROPOSED MOTION 2014-0097, VERSION 1**

2 On page 1, beginning on line 5, strike everything through page 2, line 2, and insert:

3 "WHEREAS, Ordinance 17696 contained a proviso in Section 25 stating that no
4 more than one million seven hundred and fifty thousand dollars shall be encumbered or
5 expended before the solid waste division completes a review and report on the 2006 Solid
6 Waste Transfer and Waste Management Plan and the council acknowledges receipt of the
7 report by adoption of a motion by the council, and

8 WHEREAS, the solid waste division, with participation of stakeholder groups,
9 reviewed the 2006 Solid Waste Transfer and Waste Management Plan King County, and

10 WHEREAS, the solid waste division provided an opportunity for the public and
11 stakeholder groups to submit comments and questions related to this review and
12 considered such comments and questions in its preparation of the report, and

13 WHEREAS, the executive has transmitted to the King County council the
14 requested report and a motion; and

15 WHEREAS, the extensive review process demonstrated that efforts to manage
16 self haul transactions throughout the transfer station system are needed; and

17 WHEREAS, the review further demonstrated the need for a revision to the 2006
18 Solid Waste Transfer and Waste Management Plan that would align it with the results of
19 this 2013-2014 council-mandated review; and

20 WHEREAS, revisions to the 2006 Solid Waste Transfer and Waste Management
21 Plan may also require updated traffic studies and compliance with the State
22 Environmental Policy Act;

23 NOW, THEREFORE, BE IT MOVED by the Council of King County:

24 A. The report related to review of the 2006 Solid Waste Transfer and Waste
25 Management Plan was submitted in compliance with Ordinance 17696, Section 25,
26 Proviso P1; receipt is hereby acknowledged, satisfying the proviso.

27 B. Further discussions among the cities, King County council staff, the auditor
28 and the division resulted in refinements to the report, which is hereby amended to
29 incorporate those refinements, and the amended report is set forth as Attachment A to this
30 motion. The division concurs with the amended report.

31 C. By March 31, 2015, the division shall transmit a report to the council,
32 prepared in collaboration with stakeholders, on strategies to manage transactions at
33 transfer stations, as well as other operational and capital strategies such as increased use
34 of underutilized transfer stations. The report shall address the management of transfer
35 station transactions through the use of strategies intended to avoid excessive user wait
36 times resulting from overutilization of individual stations. The report shall analyze
37 options E1 and E2 in the Transfer Plan Review Report. The report shall be accompanied
38 by a motion acknowledging receipt of the report. The executive shall transmit the report
39 and the motion in the form of a paper original and an electronic copy to the clerk of the

40 council, who shall retain the original and provide an electronic copy to all
41 councilmembers.

42 D. Upon completion of required environmental review, the executive shall
43 transmit a revised and updated 2006 Solid Waste Transfer and Waste Management Plan,
44 that aligns with the provisions and recommendations of this 2013-2014 Review of the
45 2006 Solid Waste Transfer and Waste Management Plan, together with an ordinance that
46 acknowledges receipt of the revised and updated plan. The revised and updated plan
47 shall be prepared with the participation of the metropolitan solid waste advisory
48 committee and the solid waste advisory committee. The executive shall transmit the
49 revised and updated plan and ordinance in the form of a paper original and an electronic
50 copy with the clerk of the council, who shall retain the original and provide an electronic
51 copy to all councilmembers."

53 Delete Attachment A, Transfer Plan Review Final Report, dated March 3, 2014, and
54 insert Attachment A, Transfer Plan Review Final Report—Submitted March 2014,
55 Revised and Amended May 2014.

57 **EFFECT: Striking Motion notes the need for management of self-haul transactions,**
58 **for revisions to the Solid Waste Transfer and Waste Management Plan to align it**
59 **with the results of the review, and that updated traffic studies and SEPA compliance**
60 **may also be required. A report is required by March 31, 2015; a revised 2006 Solid**
61 **Waste Transfer and Waste Management Plan is required following applicable**
62 **environmental review.**

63 **The Revised Transfer Plan Review Final Report eliminates an Appendix G that**
64 **identifies Level of Service ratings for network options, and includes matrices**
65 **identifying network capital projects, including facilities identified as being needed in**
66 **the near term, and changing the proposed new Northeast Transfer Station from a**
67 **currently needed facility to a future potential facility in the plan, as well as review**
68 **and monitoring efforts that may result in additional capital undertakings.**
