1 AN ORDINANCE relating to the Vashon-Maury Island  
2 groundwater protection committee; and amending  
3 Ordinance 14214, Section 8, as amended, and K.C.C.  
4 9.14.070

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Ordinance 14214, Section 8, as amended, and K.C.C. 9.14.070 are  
7 each hereby amended to read as follows:

8 The Vashon-Maury Island groundwater protection committee is hereby created  
9 and shall continue in existence until December 31, (~~2009~~) 2013. The Vashon-Maury  
10 island groundwater protection committee shall be referred to as "the groundwater  
11 protection committee" or "the committee" throughout this section.

12 A. The groundwater protection committee members shall be selected from within  
13 the Vashon-Maury island groundwater management plan area and shall consist of the  
14 following representatives:

- 15 1. One representative from the groundwater advisory committee;
- 16 2. One representative from water purveyors;
- 17 3. Two representatives from sewer and water utilities and associations;
- 18 4. One representative from residential well users;
- 19 5. One representative from business owners;

20           6. One representative from commercial agriculturists;

21           7. One representative from the unincorporated area council;

22           8. One representative from chambers of commerce; and

23           9. One representative from local environmental organizations.

24           B. The county shall invite each of the tribal nations with federally recognized  
25 rights within the Vashon-Maury island groundwater management area to recommend  
26 candidates for the committee. The committee shall include a representative from each  
27 tribal nation with federally recognized rights within the Vashon-Maury island  
28 groundwater management area, if the tribal nation provides to the county a candidate for  
29 appointment to the committee.

30           C. Each county abutting the Vashon-Maury island groundwater management plan  
31 area boundary shall be requested to provide to the county a candidate for appointment to  
32 the committee on an advisory, nonvoting basis;

33           D. The Seattle-King County department of public health and the Washington  
34 state departments of Ecology and Health shall be requested to provide to the county a  
35 candidate for appointment to the committee on an advisory, nonvoting basis; and



38 member represents.


Ordinance 16724 was introduced on 9/8/2009 and passed by the Metropolitan King


