1 AN ORDINANCE relating to the annexation of
2 approximately 22 acres of land into the Covington Water
3 District, known as the Arbors at Rock Creek Annexation,
4 for the purpose of providing water service.

6 **STATEMENT OF FACTS:**

- 7 1. A notice of intention proposing the annexation of approximately 22
8 acres of land into the Covington Water District, known as the Arbors at
9 Rock Creek Annexation, for the purpose of providing water service was
10 filed with the county council on March 21, 2007.
- 11 2. The Covington Water District has found the petition for transfer to be
12 sufficient and has concurred with the proposed transfer in Resolution No.
13 3539, passed on March 7, 2007.
- 14 3. The Covington Water District filed a Determination of Nonsignificance
15 on the proposed annexation dated February 15, 2007.
- 16 4. The utilities technical review committee recommended county council
17 approval of the proposed annexation.

18 5. The county council held the legally required public hearing and has
19 considered the criteria in RCW 57.02.040.

20 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

21 SECTION 1. The annexation of approximately 22 acres of land into the
22 Covington Water District for the purpose of providing water service described in
23 Attachment A to this ordinance is approved. Approval of this proposed annexation is
24 consistent with RCW 57.02.040.

25 SECTION 2. The Covington Water District is the appropriate entity to serve the
26 area proposed to be annexed.

27 SECTION 3. Completion of this annexation does not constitute county approval

28 or disapproval of any other permits, certifications or actions necessary to provide service
29 to this annexation area.

**ARBORS AT ROCK CREEK ANNEXATION
LEGAL DESCRIPTION**

The Northeast quarter of the Northeast quarter of Section 27, Township 22 North,
Range 6 East, Willamette Meridian, King County, Washington;

EXCEPT that portion thereof lying North of the South 700 feet and lying West of the
East 495 feet thereof;

ALSO EXCEPT the North 429 feet of the East 495 feet thereof.
