Project Location: Non-project proposal Affecting unincorporated portions of King

County

Project Description: Proposed Ordinance PO 2024-0387 affecting land use and zoning regulation for winery, brewery and distillery uses. Ordinance 19030 was adopted in December 2019 after a years-long process to review and update the development regulations for wineries, breweries, and distilleries (WBDs), and remote tasting rooms, in unincorporated King County. After a lengthy litigation process, on September 19, 2024, the Washington State Supreme Court published an opinion reinstating a January 2022 order from the Growth Management Hearings Board that invalidated Ordinance 19030, Sections 12 through 29, Section 31, and Map Amendments 1 and 2.

Proposed Ordinance 2024-0387 is adopted to comply with the Supreme Court's decision, as well as an evaluation by the King County Hearing Examiner that the licensing system for WBDs was preempted by RCW 66.08.120. This ordinance affects land use and zoning regulation concerning winery, brewery and distillery uses and repeals regulations concerning business licensing.
